The reason ~~dece~~ <sup>for</sup> this transition in government were all relating to bureaucracy ineffectiveness, corruption, mismanagement and ~~unstable~~ <sup>law and order</sup>. Hence, changes in the government was the ~~pro~~ <sup>fundamental</sup> reason for ~~bureaucracy~~ <sup>bureaucracy</sup> doldrums.

Secondly, political unwillingness and ineffectiveness is another ~~pro~~ <sup>reason</sup> of bureaucracy doldrums. Political parties do not pay heed <sup>towards</sup> bureaucratic effectiveness. Instead parties continue to fight with each other and blame for the inefficiency in the bureaucracy. Political parties' main focus is to just ~~eliminate~~ <sup>Need more substantive discussion plz</sup> the opposition from the ground of political arena. ~~And it is done by~~ <sup>acquiring false</sup> allegations on the ~~po~~ <sup>po</sup> other parties leaders and workers. From 1972 till 2025, all ~~po~~ <sup>po</sup> political parties were oppressed by the Awami League in the Bangladesh and use bureaucracy to favour only the close people of Awami League. ~~At every higher authority, there was a~~

representative of Awami League who used bureaucratic favoritism for the Sheikh Hasina. Sheikh Hasina never took necessary steps for change bureaucracy due to which there was delays and ineffectiveness in every bureaucratic department. Thus, political unwillingness is also to some extent responsible factor bureaucracy slowdown.

Thirdly, prevalence of demagogues and elite capture also contributes to bureaucracy slowdowns. These demagogues like select only their favorite people in their bureaucracy. ~~There is no concept of meritocracy.~~ There is dominance of elite capture in each bureaucratic institution. Demagogues and elite capture have ~~also~~ divided their departments and labelled them the department who will own this bureaucratic school. Just like in Pakistan, Pakistan's Peoples Party is acting as a demagogue in the provincial level governmental institution. ~~Whole bureaucracy is inundated with Zardari's favorite personnel.~~ Likewise, in KPK, PTI is controlling whole province. Same is the case ~~with~~ in Punjab. <sup>These are not mature examples</sup> Therefore, ~~the~~ existence of demagogues and elite capture is also the major cause of bureaucracy slowdown.

Flawed policies and procedures is the fourth factor for worsening the bureaucracy slowdowns. Governments create policies which are unrealistic and impractical for the current status quo

of the country. Just like double taxing the selected class of politician instead of widening the tax base. A person who is already paying taxes, is now bound to pay more. Another government needed to include the person who is not under the tax umbrella bracket. It is because of major companies are owned by politicians, the revenue department does not impose taxes to them, thus creating another deficiency in the bureaucratic doldrums.

Inefficient and incompetent human resource is the fifth cause of bureaucratic doldrums. <sup>Bureaucratic</sup> Governments in ~~institutions~~ hire person on their own choice. The concept of "Parchi" system still follows in the every underdeveloped nations. According to official estimates, around 40 percent of ~~people~~ are ~~not~~ selected not hired in the Bhutan. And those forty percentage people are incompetent and less-qualified than that of the person who is not being hired. ~~There~~ There is no transparency in the hiring of an individual. Seats are sold at the black cheques and hefty amounts. When such persons are hired then they worsen the bureaucracy system and further deteriorate the conditions of ~~the~~ bureaucracy. Ergo, so are the reasons for ~~bureaucracy~~ bureaucratic doldrums in any economy.

Rising corruption and other white collar crimes are the horrendous implications of bureaucratic doldrums. When there are flaws in the bureaucratic works, corruption is easy task to do. According to the UNDP 2024, nearly 25-30% of development funds in fragile states are lost annually to white collar crimes and mismanagement. Clearly, ~~bureaucracy~~ ~~doldrums~~ ~~causes~~ leads to corruption and white collar crimes.

Furthermore, scarce resources are mismanaged due to ineffective and fallacious bureaucratic works. ~~The~~ Absence of accountability, check and balance <sup>leads</sup> ~~leads~~ to exploitation of natural resources.
