As a result, the youth have gained easy access to social media and are increasingly exposed to its problems. In short, the ~~topic~~ of whether parents have left youth unguided or not have sparked many debates. Some argue that parents have not left youth unguided to grapple with problems of social media themselves. However, ground realities shows that parents have failed to guide the youth, leaving them to confront the dangers of social media themselves. To validate this thesis, there are several arguments. and left unguided them on how to deal with cyberbullying. Moreover, illiteracy of social media among parents, and ignorance of parents in teaching ethics of responsible online engagement have left youth unguided to grapple with problems of social media than their own.

Notwithstanding, this claim, there is an opposite view, which claims that parents have not left youth unguided to grapple with problems of social media. This includes imposing screen-time and building in restriction on apps to keep eye on their children's social media activity. Furthermore, some parents ask and guide their children about social media problems. However, by looking at these arguments, one may say that they are not valid and are like making mountain out of molehill.

Before discussing the topic, it is important to highlight the problems of social media to youth and role of parents. The spread of social media usage ^{negatively} affects ~~negatively~~ youth by increasing risk of mental health issues like anxiety, depression, and low

self-esteem. Moreover, social media platforms are common venue for cyberbullying and addict youth, disturbing their sleep cycle and feeling of hopelessness. A study by PEW research center (2022) reveal nearly 45% of teens report feeling addicted to social media platforms. Alongside, the United Nation children's fund (UNICEF) report on cyber safety (2021) highlights that millions of young users worldwide face cyberbullying, harassment and online shaming. On the other hand, Parents role in restricting ^{their} children are limited ~~from~~ social media. They have to foster open communication, set boundaries and encourage real-world activities. However, majority parents have left their children unguided, leading to problems related to social media among youth. A report by UNICEF (2021) on digital parenting revealed that only 30% of parents engage in meaningful discussions with youth about online safety, ethics, or privacy. Thus, Parents have left youth unguided to grapple with problems of social media.

One of the key propositions ^{the argument} that validates ^{the argument} parents have left youth unguided

to grapple with problems of social media is that parents have provided smartphones and internet without explaining risks to youth. This rapidly leads youth ~~from~~ to inappropriate and harmful content. Parents usually buy smartphones and give access of internet to their children. Youth often use ~~excess~~ ^{social media on} internet and smartphones. Their parents do not guide them about the problems of social media. As a result, youth grapple with the problem of social media themselves. According to the study of Digital Rights Foundation (DRF, 2022), parental guidance on safe digital practices is largely missing, especially in middle- and lower-income households. Hence, parents provide social media gadget to their children without telling their safety and risk.

The other argument that validates parents have left youth unguided to grapple with problems of social media is that minimal involvement in online life of youth contributes to grapple with social media problems. It increases online dangers,

including hate speech, graphic violence, and misinformation. Parents often give gadgets to their children and do not interfere in the ^{online} life of youth in society. They leave their children on their own. Consequently, children is being left on the crossroads to social media platforms. Therefore, ^{Youth} children ~~grapple~~ with problems of social media themselves. PEW Research center (2023) study, only 35% of parents actively monitor or discuss, while majority admit having little knowledge of what their children do online. This substantiates that parents engage less in online activities of youth in society.

Another pertinent point of significance that authenticates the premise parents have left youth unguided to grapple with problems of social media is that parents ignore the signs of addiction of social media. This affects the psychology of the youth negatively. Parents usually ignore the signs of addiction in their children. When these signs are

sidelined, it contributes to insecurity of social media in youth. This lack of attention ~~leads~~ to allowing overuse to escalate and negatively impact youth. This worsens the addiction ~~on~~ youth of social media, leaving youth unguided to grapple with the problems of social media themselves. A Harvard Medical school study (2021) found that excessive use of social networking platforms triggers dopamine due to lack of parents' guidance. This demonstrates that parents ignore the signs of addiction in their children, leaving them unguided ~~in~~ ^{related to} social media problem.

Equally compelling is the argument that corroborates that parents have left unguided to grapple with social media problems is that youth are left unguided on how to deal with cyberbullying and protect privacy. This leads to feelings of isolation and makes ~~them~~ youth vulnerable to deal with social media problems. A survey in META region show that 48% of children aged 11-17 hide their online activities from parents due to lack of guidance and gap of communication between parents and youth. (Kaspersky survey, META region, 2025). This highlights that youth remain unguided due to which they hide their online problems.

A fundamental idea that substantiates the fact ^{that} parents have left youth unguided to grapple with problems of social media is that parents sideline their own role in teaching ethics of responsible online engagement. This is because generational gap in tech use of parents and feelings of shy. In society, parent often depends upon other institutions for the development of moral and ethics of responsible online engagement in their children. They ignore the responsibility

of guidance regarding to social media use. This ignorance of guidance leaves youth in confusion of what to do in this situation. In Pakistan, (DRF, 2024) observed that parents often view social media as a technical issue rather than a moral one, ignoring the importance of teaching digital ethics, respect, and responsibility. This illustrates that youth confront online platform issues themselves due to ignorance of parents' ethical online engagement.

Analogously, illiteracy of social media among parents leaves children unguided to grapple with social media platform issues. The reason is that lack of expertise of parents in social media and knowledge about using social media apps. Youth remain unguided, as their parents are illiterate about the use of social media. There is also lack of expertise among parents. They often do not have knowledge about the problems of

social media. Thus, parents leave their children unguided to grapple with the problem of social media themselves. As per the research of Pew Research center (2022) on parents' lack of digital literacy, many parents, particularly in developing countries, struggle to understand the evolving digital platforms, algorithms, and online risks, leaving children navigating issues of social media on their own. Ergo, lack of digital literacy among parents leaves adolescent unguided about social media issues.

Kids Mental Health foundation's Ipsos survey (2025) ~~they~~ exhibits that 8 in 10 parents say they actively do something to manage their child's screen time. Among effective methods, setting time limits is most often cited by parents for managing screen usage. This proves that parents guide their youth ^{with} problems of social media by imposing screen-time.

Similarly, parents have built in restriction on apps to keep eye on children's social media activity. This constrains youth from doing wrong activities on social platforms. Most of parents often use restriction apps that stops children from doing wrong activity. There is also option in mobile that too hold ~~child~~ adolescent from immoral activities. ~~This~~ As a result, parents keep eye on the social media platforms activities of ~~these~~ youth. Thus, parents

According to a Common Sense Media (2023) study, 63% of parents employ built-in parental control features or third-party apps to supervise children's social media behavior. These include privacy filters, time-limit settings, and content monitoring tools, which allow parents to stay informed about online interaction. This proves that parents are not entirely absent, but rather, many use digital tools to monitor their children.

Last but not the least, some parents maintain friendly discussion, asking and guiding youth about risks of social media. This is done in educated families, reducing risks of social media to their adolescents. Most of parents, in society, make friendly discussion ~~about~~ with their children, where they share their thoughts and problems with their parents. In response, parents guide their children about the threats of social media use and try

Nevertheless, the argument presented by the opponent that parents impose screen-time on their children is not valid. Over, 70% of adolescents have come across disturbing or explicit material online, despite parental control apps, much of which escapes content moderation due to algorithmic loopholes. This justifies that youth still face harmful content that remains unregulated due to evolving social media trends.

asking and guiding children about social media problems is unjustified. As communication gap persist, because youth hesitate to share sensitive issues like harassment or peer pressure, It leaves youth unsupported. Youth often do not share their sensitive issues to their parents, due to fear of confiscation of smartphones. This can be due to peer pressure. ~~of~~ Such hesitation is largely
