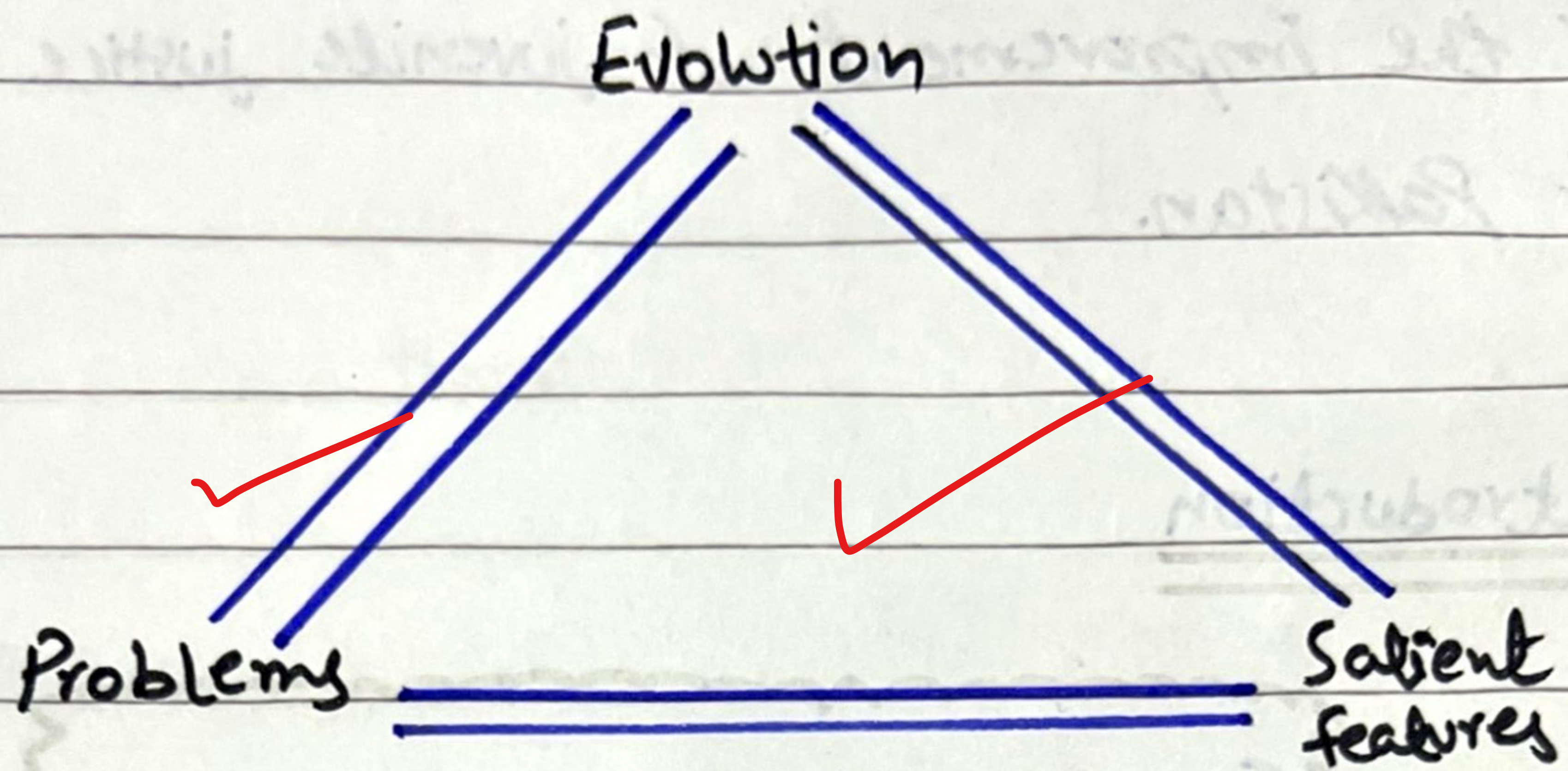
1) Introduction

It granted protection, set a legal age of criminal charge, ~~prevented~~ death sentence for underage offenders.

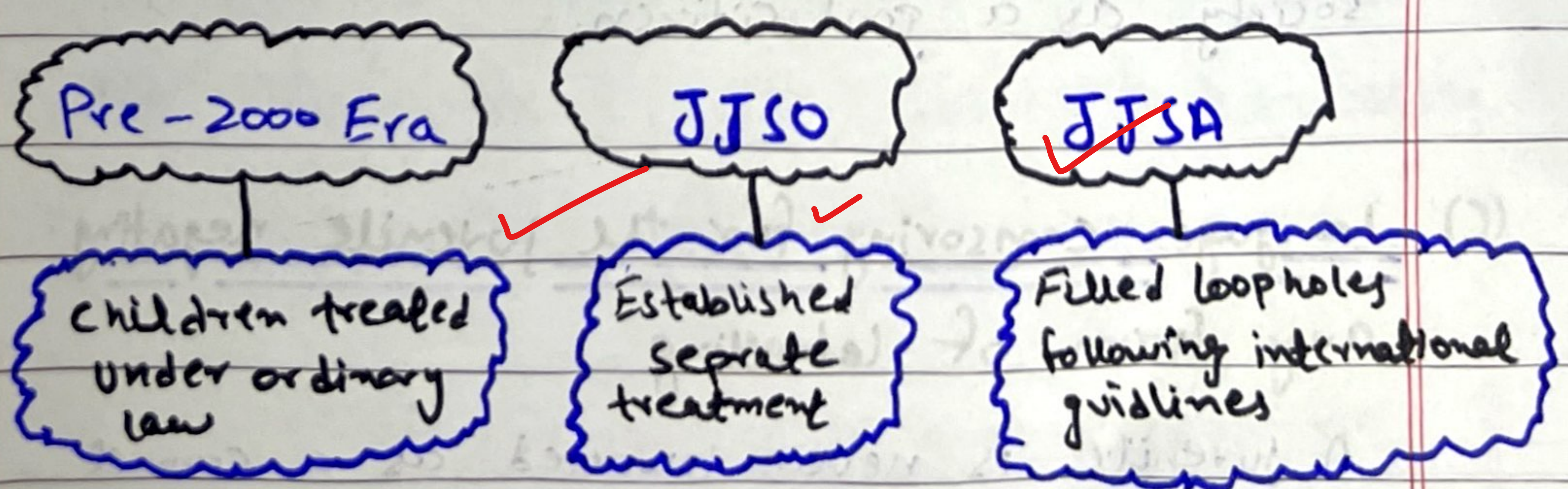

of the children 1989 and Beijing rules 1985,
to be more effective.

2.2) Salient features of the juvenile justice system of Pakistan

(a) Defining a juvenile clearly

The JJSA (2018) clearly defines a juvenile.

This alleviates any form of doubt regarding a juvenile.

Examples:-

Section 2(b) of JJSA defines a juvenile as any person who has yet to reach the age of 18

(b) Promotes restoration over punishment

The court act on the principle of Parents Patrie for the child. Hence, the main aim is to restore the juvenile back into the society as a good citizen.

(c) Language censoring for the juvenile negating any form of labelling

A juvenile is never labelled as a convict even if charged. This is done to prevent

Labelling theory states a person becomes, what he is ^{label} with. The juvenile justice system prevents this label for proper restoration.

(d) Separate detention centers to prevent interaction with criminals in jail

If a juvenile is convicted he is not sent to jail. He is sent to the detention centers, where they are rehabilitated, educated, and taught skills.

Example:-

This is done in the light of theory of differential association. In jail a child or juvenile would have negative peer affiliation, which could make them more prone to crime in future.

(e) Ball right to every children except for heinous crimes

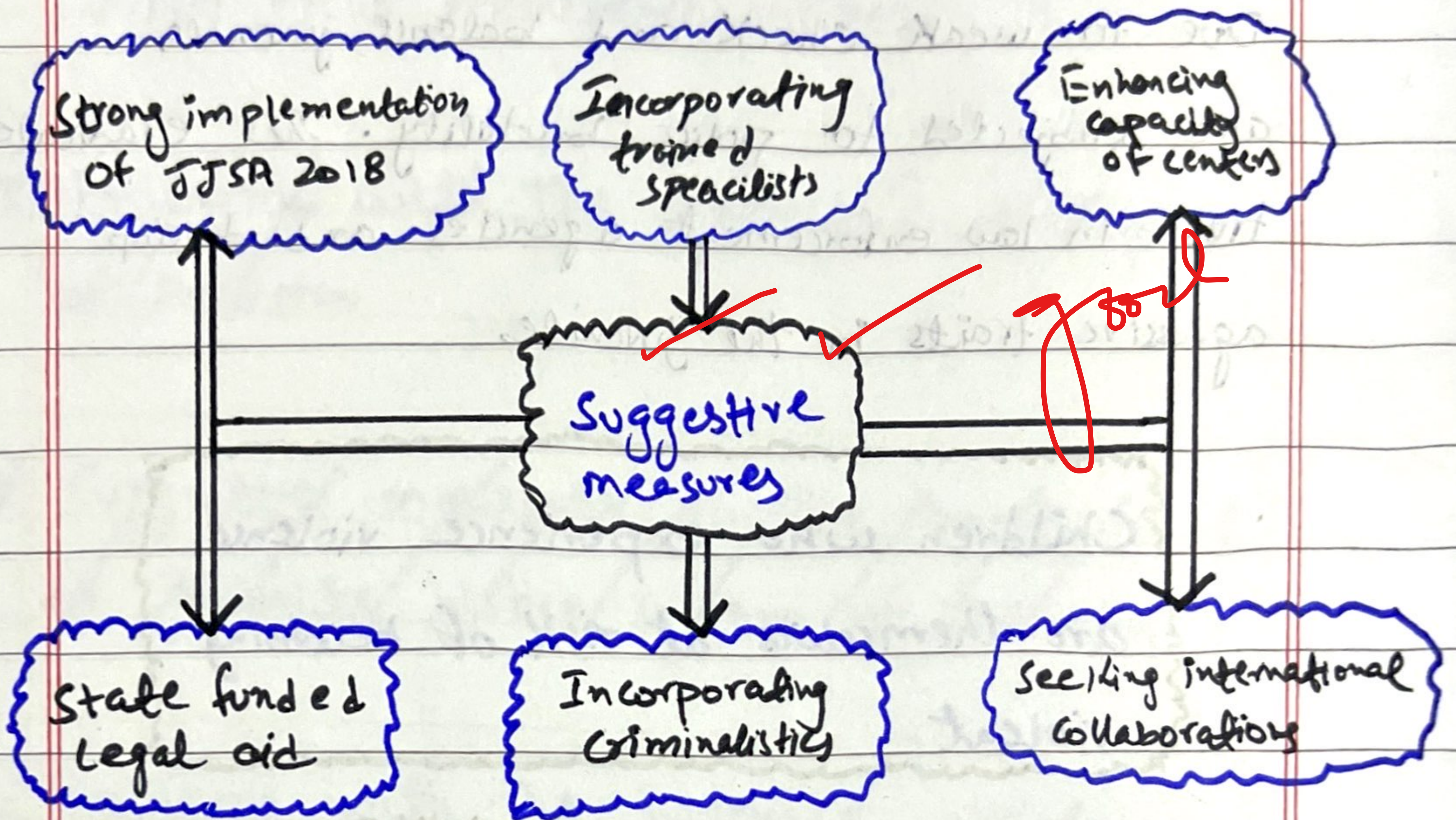
