

## SCO - Elephant and Dragon

The SCO summit has ended and Russia and China have put their steps forward to give a global governance system to South. However, there is a resistance by North against it.

The resistance by the North is very clear as Israel attacked the Yemen capital, Senna and killed Yemeni Prime Minister Naseer al-Rahawi. Benjamin Netanyahu have initiated a decisive stage in Gaza war. US naval forces are at the Venezuela shores wherein the Russia Ukraine conflict is ongoing and there is a threat of Israel strike on Iran.

The 1% of global population controls the 40% of global wealth whereas the 50% controls only 2% of global wealth. According to WHO report there are more than one

billion people who are suffering from mental disorder so the question is world wants peace, prosperity, cooperation or war?

Last year Indian Foreign Minister S. Jaishankar forward a proposal of de-escalation of Ladakh but China has very strong stance on it as it is related not only to one China Policy but also with Pakistan's sovereignty and waters.

The Trump tariffs on India advanced its tilt towards SCO and BRICS, although it is half hearted. As India wants 2026 BRICS presidency.

Post 2022, India's imports from Russia have increased in oil and fertilizers but it is not like as Jaishankar say "Russian-Indian trade is only constant in world politics". After the

Soviet Union collapse, India left the socialist block and joined capitalist. From 1991 to 2024, the trade between India and USA grew from \$5B to \$128B in which \$20B are in defence sector. India left the MiG Series for French Rafale and also Submarines for its French and German variant.

India <sup>has</sup> also cancelled the order of Mi-17 VS helicopter and Ka 31 Airborne Early warning helicopters. So, now India is in a sticky situation because its top-notch weaponry is from NATO partners that do not give choice to side walk their alliance.

So, if India wants to befriend of Dragon it has to change its defence architecture which will cost it both in terms of monetary and diplomatic investments. By doing this each elephant would be equal in the tribe.

On the other side, Dragon should not have to worry as it invited everyone
