Moreover, the lack of a clear and comprehensive policy framework to counter the growing population is also worsening the situation. According to a report of United Nations Division of Population, Pakistan's population is around 256 million and it is rapidly rising, but there seems to be no serious policies and planning for controlling the population growth; therefore, the unavailability of a clear population control or family planning is a key contributor in Pakistan's largely growing population.

Rise in a fertility rate and decline of the mortality rate is one of the very primary causes of overpopulation in any country. So according to Pakistan Demographic Survey 2020, the fertility rate is 27% and the mortality rate is only 6.7% which shows a clear wide gap. Therefore, the government should make effective policies to decrease the birth rate which is very alarming for Pakistan.

Similarly, the decline in the mortality rate can be due to the advancement of the health-care technology, as in previous times minor diseases and infections used to kill millions of people, like Spanish flu killed more than 9 million people. Thus, it can be concluded that the technological advancement has also equally contributed to overpopulation.


