→ Health aid flows more towards allies of donor countries (OECD report)

→ USAID funding comes with certain loss of sovereignty

→ Cloudbursts more frequent in Himalayan region (IMD report)

→ Uttarakhand 2013 floods

→ Himachal Cloudburst 2021 linked to sea surface warming (Nature Climate Change report)

4.1 Infrastructure and economic loss due to urban flooding

→ \$30Bn loss suffered in 2022 floods (World Bank) by Pakistan

4.2 Damages to crops and agriculture output, raising food security concerns

4.3 Loss of human lives and displacement through landslides and flash floods

→ 200+ killed in Uttarakhand 2013 flood as result of cloudburst (World Bank)

4.4 Water borne diseases, culminating in a public health crisis.

→ Stagnant water breeds dengue, malaria
