Pakistan has been ranked 148/148 in Global Gender Gap report of 2025, published by Women Economic Forum. It is an alarming situation that clearly indicates about the gender inequality. Unfortunately, in Pakistan women are treated as second-class citizens. For example, in Politics, there is negligible representation of women. Similarly, there is lower voter representation during elections. Apart from this, women are often ignored in decision-making. Women plays a vital role in boosting economy of a country, but in Pakistan there is lesser labor-force participation. The plight of women in the field of education is also appalling. There is much lower literacy and enrollment rate. Moreover, women face disparities in the field of sports too. All these points indicate the injustice faced by women due to patriarchal mindset. To begin with, there is negligible representation of women in the field of politics clearly indicates that how they are sidelined in an important field of country. Politicians are representative of people. They have an important role in policy-making. Policy-making is basically done to resolve the issues being faced by people. If there is lesser representation of women in politics, there would not be any effective policies for women too. According to the report of UN Women Organization, only 20.47% seats are held by women in national parliament of Pakistan. This fact clearly indicates the under-representation of women in politics - not getting the same chances as men.

Despite this basic right, there was very low voter turnout in the elections of 2024 - only 40% women have casted vote. This shows that how women are deprived from this basic right - they couldn't choose a leader of their own choice. Hence, women do not have same chances as men.

Moreover, women in Pakistan are ignored during decision-making - decisions of someone else are imposed on them. Decision-making is an important factor in every walk of life. They have the potential to reshape the destiny of one's life. Unfortunately, in this patriarchal society, women do not possess this right - whether in home or at workplace. For instance, women do not have right to choose their life partner, or their career in many areas of Pakistan. It's the men - her father or her brother, who will decide it. Hence, women in Pakistan do not have same chances as men.

Further, in Pakistan there is lesser labor force representation of

Women. Labor-force tells about how many people are doing jobs and earning. It is directly related to the development and growth of the a country. Unfortunately, labor-force participation of women in Pakistan is only 22.6%, according to International labor organization. This means women are not doing jobs-particularly due to dogmatic norms of male-dominated society. Thus, women in Pakistan do not have same chances as men.

Furthermore, women have limited access to financial services. This is a surprising fact. Women do not have autonomy over their money. A woman may have various issues or require money for basic needs, and for that every single penny, she is dependent on a man. According to Dr. Reza Baqir-Former Chief SBP, only 29% women have bank accounts. This is a very low number. These facts clearly indicates that how women are being treated as second-class citizens. Hence, it is a proven fact that women in Pakistan do not have same chances as men.

Moreover, in Pakistan women have low literacy and enrollment rate. Education is the basic right that has been given by ^{both} religion and constitution ~~both~~. Women are often discouraged from getting higher education in the name of religion, but teachings of Holy Prophet (PBUH) clearly mention that education is an obligation upon Muslims regardless of gender. It's a pity that literacy rate of women is 52% as compared to men, i.e. 72%. Despite having, both, religious and constitutional right, women are sidelined in the field of education - leading to major women issues in future. Therefore, it is of no doubt that Pakistani women do not have same chances as men.

Apart from these, women have been deprived from their right to have inheritance since the very first day. Like education, inheritance is also a religious and constitutional right. In Islam, women have fixed share of inheritance, but unfortunately, a country that's ideology was based on Islam, is depriving women from their basic rights. In 2017-18, a Demographic and Health Survey was conducted

that showed only 3% women own property in Pakistan. It is like drop of water in an ocean. Those 97% are still facing the illness of patriarchal mindset. Hence, this argument clearly supports the point that women in Pakistan do not have same chances as men.

Not only that, women are also deprived of their legal rights. Legal rights ensure one's safety or role in the society; however, implementation of these legal rights require societal acceptance. Otherwise, these laws are nothing less than a piece of paper. Unfortunately, in Pakistan rape, honor killing, and gender-based violence is on surge for the past few decades, but there is nobody coming forward to stop these. For instance, Sobra Batool, a Pakistani woman, was attacked ~~by~~^{with} axe by his father and brother. Her mistake was ~~that~~ demand of divorce. Luckily, she survived but no action was taken against the culprits. Things like these are common and became a norm. In these situation, nobody can claim that Pakistani women have same chances as men.

Similarly, Pakistani women are facing disparities in health and nutrition too. Women are physically weaker than men. They require balanced diet and nutritional food to maintain their health like men too. However, during pregnancy, they require intensive care, as they are going to give birth to a life, but there is a greater mortality rate of women in Pakistan—due to poor diet and health facilities. Apart from this according to Pakistan Business Recorder Report, 41% women are anaemic while 22.4% are having Vitamin A deficiency. These facts speak loudly about injustice being done with women. Hence, it will be wrong to say that Pakistani women have same chances as men.

Apart from these, Pakistani women are also facing disparities in sports. There are a lot of women athletes in Pakistan who represent the country at international level in various sports. Like other professions, in sports, too, women are standing shoulder by shoulder. Moreover, they have had an excellence performance too. However, women are facing disparities in this profession too. For example, the category A players of men team receives higher
