Introduction:

Community Policing has been established to enhance the coordination between police and public by actively involving communities in the affairs of police. In Pakistan Police order

2002, requested the establishment of two such bodies including Citizen Police Liaison Committee and Public Safety and Police Complaints Commission. These bodies have immense

potential in dealing with crime reduction
promoting social cohesion and increasing
public confidence in police. But
in Pakistan very less progress has
been made in this manner. It
is required to adopt active policies
to promote community policing in
country.

Definition:

Community policing is philosophy
of policing, which include involvement
of community in management and
planning of police affairs.

Sir Robert Peel's principles of Policing

Sir Robert Peel, A British
Statesman, developed 9 principles of
community policing.

Principle 1 provided that

Police should maintain a relationship with public based on tradition that police is public and public is ~~police~~. Policeman is the only person who gets money for paying attention to his duties, which are incumbent on every citizen of state.

Community Policing in Pakistan:

Police order 2002, provide two bodies for community policing.

1- Citizen Police Liaison Committee

Government of Pakistan is required to establish this body under Police order 2002. It is autonomous, self-financing. It also required the training and capacity building of Police.

2 Public Safety Police Complaint Commission

It is designed to address the complaints of public against police. But it is not active institution and framework largely limited to statutory powers.

Benefits of community policing:

Enhanced Public confidence in police:

Community policing involve public in police affairs and enhance confidence in police. It also required the redress of complaints against police.

Save Police time in unnecessary trials and arrests.

Community policing result in resolution of social issues and disputes. Thereby help police in saving time

✓ of unnecessary arrest and detentions
Peaceful Co-existence:

✓ community policing enhance
coordination between public and police.
It increase crime awareness and
social monitoring and promote peaceful
coexistence of communities.

✓ Less burden on criminal system

Many disputes can be
resolved by the involvement of
community along with police before
registration of cases. In this way
it reduce burden of cases on
justice system.

✓ Challenges of Community
Policing in Pakistan:

In Pakistan Community
Policing has not been actively
developed and out of two bodies

one is restricted to papers of statute with no implementation.

The major challenges in its development are highlighted.

Lack of Budgetary allocations.

Weak governance system.

Involvement of Politicians and powerful in police functioning.

Lack of competency in Police.

Absence of local government system

Weak recruitment process of police.

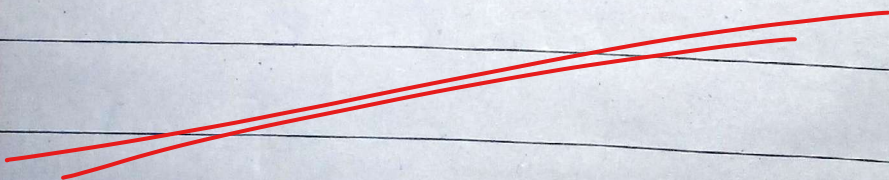
- its functioning.

Crime is the major problem at individual and social level within societies, yet there is no society in the world having complete absence of crimes. Most of the crimes are violent in nature. Other major crimes are organized crimes, petty crimes and corporate crimes. Based on these crimes, criminals

are categorized as habitual, occasional and professional criminals. These criminals pose grave threat to the survival of society and required the strong implementation of law and enhance communication between public and law enforcement agencies.

Types of crimes:

Definition:

Types:

Infractions:

These are the small violations of law and contain punishment of fines only.

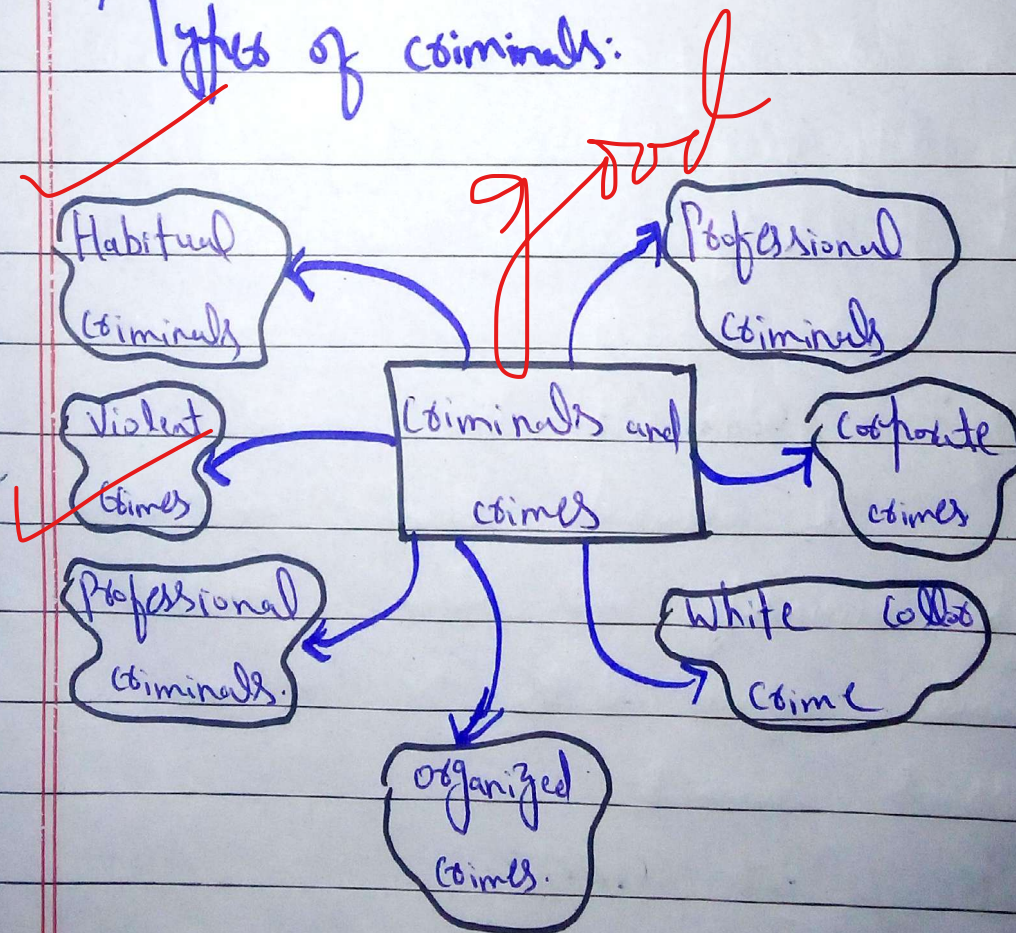
Misdemeanor:

Felony:

Types of criminals:



Occasional criminals:

Criminal who commit crime in ~~response~~ to external stimuli or to ~~avail~~ opportunity. Such criminals are ~~receptive~~ to rehabilitation.

Habitual criminals:

one who commits numerous crimes and becomes hard core criminals. They are incarcerated as they pose threat to society.

Professional criminals:

He obtained bread and butter through criminality and when ~~when~~ habitual criminal acquire ~~skills~~ he becomes professional criminal.

White collar crimes:

These are non-violent crimes committed for financial gain by those, who acquire high status in

society. for example, money laundering,
bribery

organized crimes:

These are committed by
collaboration and coordination of group
of individuals. Trafficking (Human, drug
and arms), Fraud, gambling, Pornography,
Theft, robbery and hijacking.

corporate crimes:

These are committed by
corporate entities including unfair business
practices, money laundering and insider
trading.

Violent crimes:

These are the crimes in
which physical force is employed by
offenders against victim such as rape,
murder and robbery.
