Pakistan has been facing different issues since its birth.

Problems like, early death of political leadership, economic problems, constitutional problems and strategic problems as well.

Main problem was early death of loyal political leadership of Pakistan.

Quaid-e-Azam, the founder of Pakistan was passed away soon, then first Prime Minister of Pakistan Liaquat Ali Khan was assassinated and so on. These were main set backs for a resilient state.

Pakistan faced administrative problems also since its birth. Shifting of people, and their placement was even more difficult.

However, Pakistan, with early problems, survived.

Another major problem that caused crisis of Government in Pakistan was, delay in formation of first constitution of Pakistan. The first constitution was formed after 9 years of birth of Pakistan in 1956.

Another issue Pakistan has been facing is, invention of undemocratic forces in the country.

Martial Laws, in this country, has made it as a unpredictable country like, no one exactly knows that any dictator may violate the Constitution and he stays as long as he enjoys the dictatorship.

Martial Laws like 1958, 1977, 1999 and emergency of 2007, made this country as a weak democratic state.

Government Crisis has been main issue problem of Pakistan in its every era.

Dictation of necessity played a worst role in good governance - Pakistan

was divided into East Pakistan and West Pakistan.

There were reservations about more than enough role of

But all situation faded to interfere government crisis. One of the reasons of government crisis is institutional weaknesses. Institutions in Pakistan have been remained under the influence of personality of head of the relevant institution.

There have been lack of professionalism in institutions. It created government crisis in Pakistan. Politics in judiciary and other institutions has created main problems.

Q: In good governance, attention is paid to human rights and, but due to poor governance, people are facing human rights violation. No one, how who is in government, cares of people, whether they are enjoying human rights or not. Almost 16 Crore

people are under poverty line, report presented by World Bank.

One of the biggest consequences of this of bad policies is lawlessness in Pakistan. whenever and where ever there is absence of good policies lawlessness will prevail that people now due to bad policies they will escape from punishment. Bribery is their main weapon by which they prey their victim. One more consequence is underdevelopment of political and democratic culture in Pakistan. Poor policies do have many problems, then the flattening of political culture in which democratic values become mature.

This maturity helps in character building of the society in the country.

There are some necessary steps, need to be taken to get out of crisis of good governance in Pakistan.

First step, should be taken, is rule of law. Rule of law can change each and everything in correct way. It is foremost force that changes a society completely.

Another step is civilian supremacy in the country. Pakistan does have Parliamentary form of government - civilian government is chosen by public of Pakistan. No interferes of undemocratic forces in civil institutions. Whenever powerful institutions do have illegal interferes in matters of other institutions, it creates a complete shambles in the country.

Pakistan is a democratic country. In democracy, local government is basic feature of democracy.

Local government system should be strength at ground levels.

Strict accountability is needed in the country.

There should be a proper legislation in Parliament.

These laws should be made on priority bases, and those laws must be implemented - laws must be equal for all citizens

of the country. No one should be above the law.

Another step which should be taken is, free and fair elections in Pakistan under the Neutral election commission of Pakistan.
