The extremist propaganda and fake news are used by the terrorist organization to recruit young people.

In addition, political propaganda and fake news led to the manipulation of election result and violation of the sovereignty of a country.

Similarly, it is used to malign the image of a country internationally. Furthermore, it is used as a tool to

justify the massacre of innocent civilians. Moreover, it is used to alter public opinion and reduce efforts to mitigate climate change. It is a need of a time, to hinder propaganda and false news. To counter propaganda and false news, early education should be used to counter propaganda and false news. Similarly, effective legislation to regulate media outlets and the habit of factchecking before the dissemination of information are highly required. Thus, the biggest threat of the current age is propaganda and false news as it is used in the recruitment of militant organization and manipulation of election result. However, it can be counter by legislation and factchecking.

Propaganda and false news are two terms with

similar meanings. Propaganda and fake news means the biased and false information which is used at political and vested interests. The information concerned has nothing to do with the reality.

The extremist propaganda and fake news are used by the militant group to recruit young people.

These outfits brainwash young people by glorifying people who detonate themselves in bomb blasts.

Similarly, they promise monetary gains to young people after joining the organization. The youth due to financial problems and unemployment join such organizations. To illustrate,

TFP, a militant group involved in terrorist activities in Pakistan, use social media apps like WhatsApp to allure young people.

to join its group. Thus, propaganda & particularly anti-state, and fake news are used to recruit youth in the terrorist organizations.

The political propaganda and fake news are used as a tool to manipulate the election of a country. This tactic is used by the enemy country to hinder free and fair election. As a result, the winning candidate does not have political legitimacy. It leads to political instability and economic crisis in a country. For instance, Russia intervened in the US 2016 elections by spreading fake news against the opponent of Donald Trump. As a result, Donald Trump won 2016 Presidency with the help of Russia. Thus propaganda & fake news

① are used to alter the result of elections in one's favour.

The propaganda and false news are also used to violate the sovereignty of a country by a waging wars. Some countries use false narratives and accusations to wage war with the enemy country for political gains and vested interests. For example, India used the fake flag operation of Kargil to justify military aggression inside Pakistan. Similarly, the US invaded Iraq on the pretext of the presence of weapons of mass destruction. Thus, propaganda and false news are used by the aggressive leaders to launch attacks in the enemy countries.

The extremist propaganda and false news are used

to justify the massacre of innocent civilians. Several aggressive leaders view minority group with contempt. Therefore, they use propaganda to create animosity in the hearts of majority group or a minority. As a result, they have public consent for killing minority group. To illustrate, Hitler used propaganda to justify the decimation of Jews in the holocaust. Similarly, the government of Myanmar used propaganda to kill Rohingya Muslims. Hence proved, propaganda is used to justify the mass slaughtering innocent civilians.

The political propaganda and fake news are used to besmirch the soft image of a country. In recent days, soft image of a country is important for

vaccine to their children. Similarly, during Brexit, some politicians spread false news that leaving European Union will be beneficial for medical funding. As several funds will be reallocated for health. Thus, false news are widely used to manipulate public opinion.

Some climate sceptic people use false news to reduce global efforts to mitigate climate change. As transition to green energy will result in the loss of profit from using fossil fuels. As per the Economist report, about \$10bn are used annually to publish literature against climate change measures. As a result, the burning of fossil fuel goes unabated. Thus, anti-climate change lobbies and false news to prevent the transition

away from fossil fuels
to green energy.

Educational indoctrination, tool of propaganda, by the elites to extend their stay in power. Historically, politicians have used educational text books to propagate certain narrative in the public. As a result, they extend their rule. For example, Hitler used educational indoctrination to propagate anti-communist agenda. Similarly Altaf Anjum stated in his book, "What's Wrong with the Education in Pakistan" that political elites in Pakistan have used education for indoctrination and justification of their rule. Hence proved, education is used by the powerful to achieve their vested interests.

Lastly, propaganda and

smear campaigns run through social media to defame people. Some people with their malevolent intent spread false news about renowned people. As a result, the image of that person is intentionally tarnished to achieve certain gains. To illustrate, Meesha Shafi, a famous singer, accused Ali Zafar of harassment. To counter her false accusation, he filed a defamation case against her. Thus, false news are being spread to defame famous people.

The above aforementioned paragraphs explained the threats of false news. The following paragraphs will explain how to counter propaganda and false news.

Through early education,

children should be equipped with the skills to debunk propaganda and fake news. With the relevant skills, children would be able to differentiate between fake news and credible news. As a result, fake news will be hindered. To illustrate, Finland equip the students with all the relevant skills, to differentiate between credible and fake news, from the early years of their education. Thus, early education and awareness help to hinder propaganda and fake news.

Social media outlets should be regulated to reduce the spread of fake news and propaganda. For this, effective legislation should be made which will discourage social media outlets from spreading fake news. In addition, strict penalties will also help in this regard.

For example, Pakistan Electronic Crime Act, 2016 was promulgated to prevent the spread of false news by imposing strict penalties. Hence proved, regulation of media outlets can prevent the spread of false news.

The encouragement of factchecking, before the dissemination of information, can prevent the spread of propaganda and false news. Fact-checking helps in validating the authenticity of information.

For example, Harkai stated in his book "Nexus" that false news can be countered through fact-checking. Hence, the habit of fact-checking through various sources can hinder the dissemination of fake news.

In a nutshell, among many threats, fake news and propaganda are proved
