

Q: Differentiate between crime, deviance, sin and vice. Discuss that crime is one of the major social problems of Pakistani society.

Introduction:

The central core of law and enforcement is to maintain peace by any mean and avoid any possibility of crime.

Crime is known as an act against any law described by society; breaching laws lead to punishment. At the same time, sin regards an activity against religious doctrines or principles that causes the wrath of God.

Moreover, vice is a term used to describe any immoral activity of a person which brings questions to the integrity. Furthermore, deviance is acknowledged as breaking the laws of society; in this informal methods are devised to control deviant behavior. Most of the time friends and family of the person make sure that person should not go toward deviance. Crime is a social evil which is present in every society in one or another way, Pakistan is no exception.

Dacoit cases, Rape cases, terrorism, murder, homicides, theft and many more are deposited continuously to show the terrible condition of the state. Crime is a social disease which does not live alone but put other items with itself, it invites poverty, unemployment, distrust, decrease of belongingness and cooperation, and diminishing quality of life as well as rule of law.

a. Crime:

Crime is an 'act' or 'omission' which is prohibited by criminal law. Every state sets out a limited set of acts as criminal.

In order to do so, certain kinds of punishments would be given including fine, imprisonment or some other form of punishment.

✓ According to Criminologist Paul Tappan (1960)

"An intentional act or omission in violence of criminal act or law, committed by without defense or justification, and sanctioned by the state as a felony or misdemeanour."

✓ For Example:

Murder of someone without self-defense or under the law is considered as a crime.

How to control this?

Proper Laws under penal code to punish murder should be implemented irrespective of any division. Moreover, enforcement should be strong enough to call in action against murder.

b. Sin:

— Sin is any activity which is against religious principles. Religious rules and laws

✓ are not followed by someone and breaching religious laws are termed as sin.

For Example:

Breaking promises, telling a lie and not offering prayers are sins.

How to resolve sins?

Religious sanctions are devised to control religious sins e.g., Hudood ordinance Act in Zia-ul-Haq's period is an example in this regard.

✓ c. Deviance:

Deviance is a violation of social norms defining appropriate or proper behavior under particular set of circumstances. It encompasses sharply different behavior from a customary, traditional or generally accepted standards of a society.

For Example:

Do not obey the elders, eating with left hand and do not keep silence while Azan are considered as deviant behaviors.

Deviant behavior can be caused by keeping company of such friends who promote deviance.

How to control deviance?

Deviance can be controlled by parents and friends. Parents and good friends make sure that a deviant person should not go towards deviance.

d. Vice:

Vice is an immoral act of a person, that causes harm to the society in some way. People who commit vice faces strong and harsh criticism by the society.

For example:

Prostitution is a vice that is prevailed in different societies in order to beat the poverty.

How to resolve issue of vice?

Informal society rules can assist to control vices of people, in another way, society calls negative terms for them that can hurt the integrity of people. In this way, people can avoid committing a vice for their honour and respect in the society.

Most of the youth are unemployed in Pakistan. A large number of youth come out of universities but unemployment causes



According to Strain theory, crimes occur when people do not have legitimate opportunities to achieve normal success goals in society.

There is always a positive association between crime and unemployment. Moreover, urbanization is also a contributing factor, a mass number of people move toward cities; no proper management increases the ratio of crimes. That's why, safety of cities are compromised in this process.

Crimes mitigate the feelings of connectedness and cooperation; officers who commit white collar crimes cause decrease of sense of integrity in subordinates. According to National Bureau, atleast Rs.10 million corruption is caused by high officials each years.

Furthermore, social disorganization theory of Shaw and McKay explains the due to criminal behaviors of parents, children faces neglect, and sense of otherness which lead them to continue the footsteps of their parents.

Moreover, weak role of state institution can aggravate the situation of crime. Crimes increase distance, and it gets very difficult for the person to get genuine help from another person.
