Corruption is the abuse of entrusted power for personal gain. It includes actions like bribery, nepotism, fraud, and misuse of public office for private benefit. Corruption can lead to polarized the legislative and judicial systems for personal gain. While, these personal gain can disrupt the whole system of the Pakistan by executive system. Similarly, these misuse of the system can lead political instability and lack of accountability, bad governance, interference in constitutional system, nepotism, and military intervention in the political system of the Pakistan. However, these may affect the educational system and natural resources; enhancing mistrust of the public, increasing in economic degradation and lack of rule of law. In these, corruptions have enhance bad governance, lack of political instabilities; and fall of democracy; while in contrast, affecting all these systems which stabilize Pakistan international and world wide.
