Pakistan's media reflects three model of effects - powerful, limited, and moderate - but in contemporary practices, the moderate effect model emerges as the most applicable. Neither overpowering nor negligible, media in Pakistan conditionally cultivates attitudes, frames debates, and sets agendas. Its role is most visible in politics, society, and cultural transitions where public perception is gradually shaped by repeated and narrative framing.

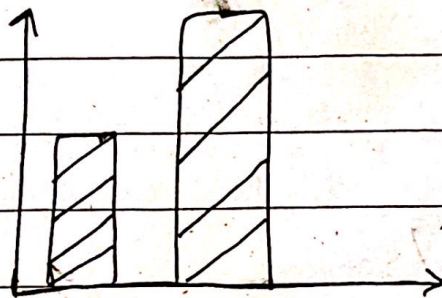

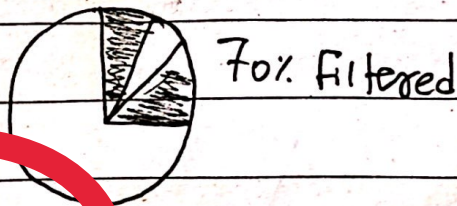
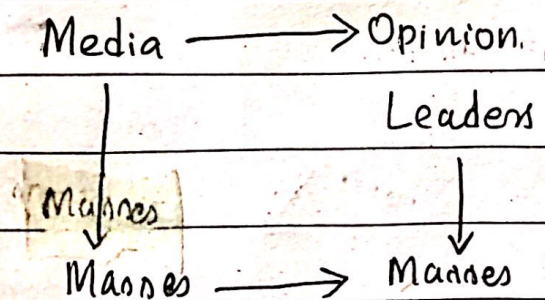

and opinion leaders before reaching individuals.

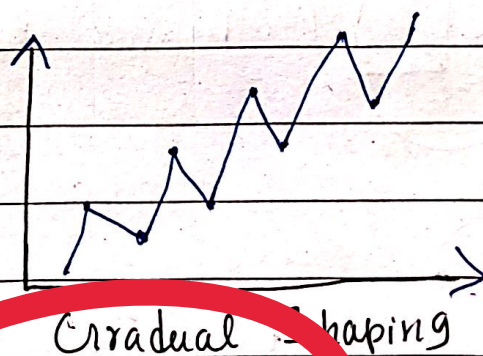
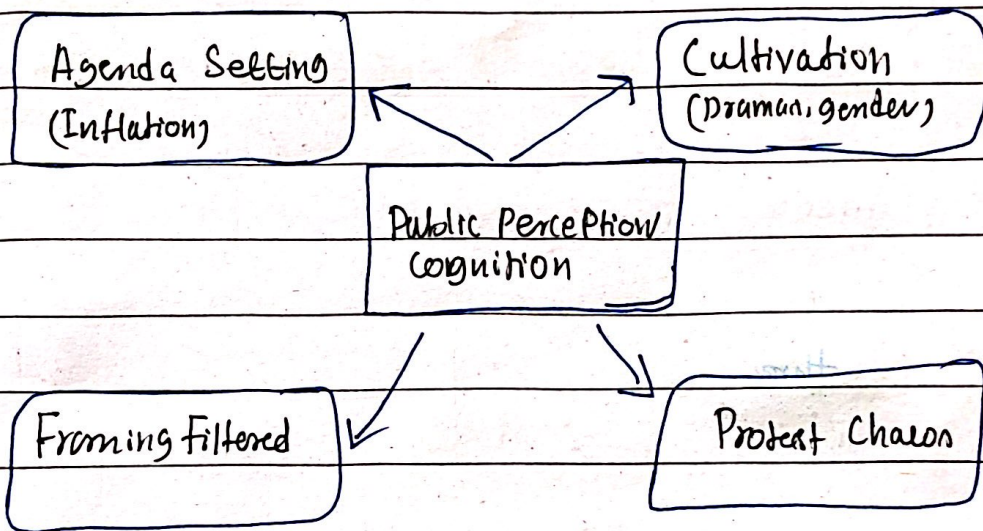

Since Private channels' growth after 2002, audiences gained choices, weakening powerful effects. Media now operates within pluralistic dynamics, reflecting

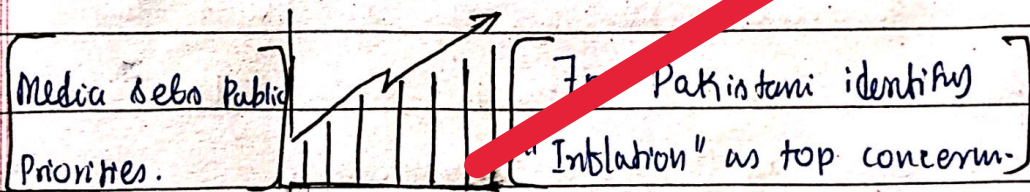

Continuous coverage of inflation by GEO and ARY shaped economic discourse. McCombs and Shaw's Agenda-Setting Theory explains how salience of "mehnagai" became Pakistan's most discussed societal and political concern.

(c) Cultivation Theory in Pakistan Television dramas

Cerber's Cultivation Theory applies in dramas like "Mein Zaat Zara-e-Benishan", which gradually reshaped debates on child abuse, women's

Gradual Norm Shift: → "Udari" drama watched by 15M, contributed to 25% ~~in~~ ~~the~~ Child Abuse awareness.

(d) Framing Theory in Political movements and marches

Entman's Framing Theory clarifies coverage of PTI's long marches. Some media framed protests as democratic struggle, other as chaos. This selective framing steered citizens' discussions and influenced political alignments.

(e) Spiral of Silence in Blasphemy-related issues

Noelle-Neumann's Spiral of Silence explains Pakistan's silence on blasphemy debates. Citizens fear isolation; media reinforces conformity.

Selective Exposure Theory
