

Ques What are the Sites and Forms of violence against women in Pakistan and how in your view this menace can be eliminated from our Society?

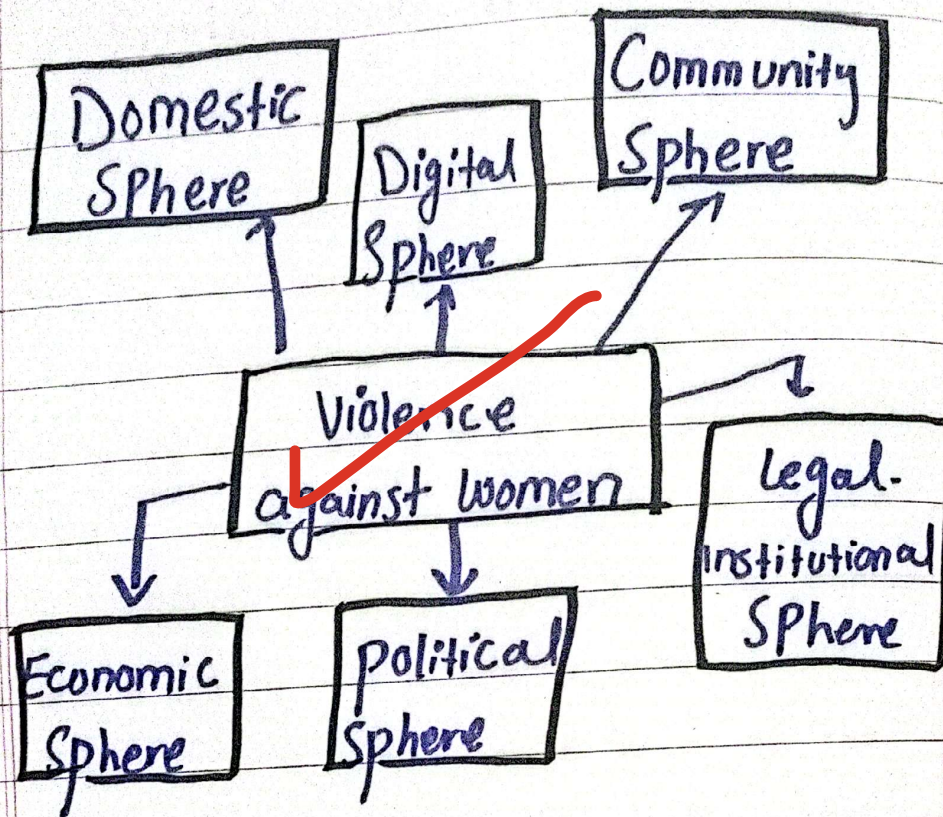
1. Introduction:

2. Sites and forms of violence Against women in Pakistan



a) Domestic Sphere : Intimate partner and Familial Violence

Home remains the most dangerous site. Women face Spousal abuse, dowry-related violence, marital rape, & honor-based restrictions, often silenced by cultural taboos.

b) Community Sphere: Honor Killings and Collective Punishments.

Jirgas often sanction karo-kari and Vani. These practices reflect collective control of women's bodies, legitimizing violence through feudal-patriarchal structures of community justice.

c) Economic Sphere: Workplace Harassment and Exploitation.

Women in workplace face harassment, wage discrimination, and exploitation. Despite law like the 2013 Act, enforcement remains weak, limiting women's economic participation.

Abuse, character assassination, and exclusion. Studies by Farzana Bari show gender quotas often provoke patriarchal backlash within assemblies.

e) Legal-Institutional Sphere: Weak Enforcement and Secondary Victimization.

Police inaction, hostile courts, and insensitive medico-legal procedures re-victimize survivors. Shaheed & Mehdi note "law ~~en~~ books" fails in patriarchal legal culture.

f) Digital Sphere: Cyber Harassment and Online Violence.

With increased internet usage, women face trolling, blackmail, and revenge pornography. Aurat March reports highlight cyber violence as a ~~new~~ patriarchal frontier.

Progressive scholars like Asma Barlas reinterpret Islam as egalitarian. Countering misuse of religion can delegitimize honor killings and gender violence in society.
