of our economic, political and social life, people are involved in world affairs, and economic lives of people are increasing in their standards. Moreover, the rise of accountability through social media is an unmissed prospect. Despite these prospects, there are some problems which are rising due to uncontrolled spreading of social media; social media is being used as hybrid war and defamation. Along with these problems, the crisis of health, causing due to social media cannot be set aside. Similarly the assassination of Saudi Journalist Jamal Khashoggi at the Saudi Consulate in Istanbul on 2 October 2018 was also a part of hybrid war through social media. All these show that social media is being used as an instrumental of hybrid war.

Adding further, social media has emerged as a tool of defamation. Different social media devices are used by individual as well as countries to defame others for their vested gains. It causes personal and countries damage. Using of social media for as defamation tool is also known as labeling theory in social science. In recent times, Israel is defaming Iran and Qatar on social media. Similarly Ukraine is also defaming Russia on social media at international level. In Pakistan Ali Zafar and Meesha Shafi case was in air. Meesha Shafi alleged Ali Zafar for harassment in the court. Although he was set free but was defamed on many public stages. Similarly Deputy Commissioner Muzaffar Gani Usman

Tahir defamed by social media users whereas he was rescuing the people in flood of 2025. At end, this tool has caused many deaths when some innocent persons were defamed. It clearly shows that social media defaming tool is one of the biggest problem.

Among some other problem related to the growing power of social media is the rising health crisis. Before the spread of media, one sit to with one's family and friends for which physical and face to face interaction was necessary. It was source of mental happiness. Now all these activities are restricted to virtual interactions only.

Almost 5.41 billion people are using social media globally which is 65.7% of the total population. Every one sits

in his room and interact with his family and friends virtually. This creates a feeling of loneliness. Fake and unauthentic news is spreading causes depression and anxiety among the public. According to U.S. News, experts have found that social media use appears linked to negative mental health impacts.
