The Paris Agreement committed to curb global temperature rise to below  $2^{\circ}\text{C}$  on average average. However, such pledges not followed through, primarily due to the non-binding nature of majority agreements. Similarly, policies regarding Carbon Trading were introduced. This inadvertently led to greater emissions and greenwashing practices by organizations. In contrast, practical actions are needed to effectively deal with climate change. Reducing the use of fossil fuels by shift towards electric and hybrid systems is an important step. Similarly, afforestation efforts, with involvement of the community, needs to be initiated. Replication of initiative like Billion Tree Tsunami is a potential example. Furthermore, sustainable practices need to be undertaken in agriculture and industry sectors. waste management
