
4. SCO and BRICS: Challenge to American politicoeconomic dominance in world Politics

A. Countries re-engineering their alliances

E. SCO and BRICS: Purchase of military arsenal from Russia and China

Member states are purchasing military equipments and arsenal from Russia and China rather than relying on United States, France and United Kingdom, thus, harming US hegemonic role.
