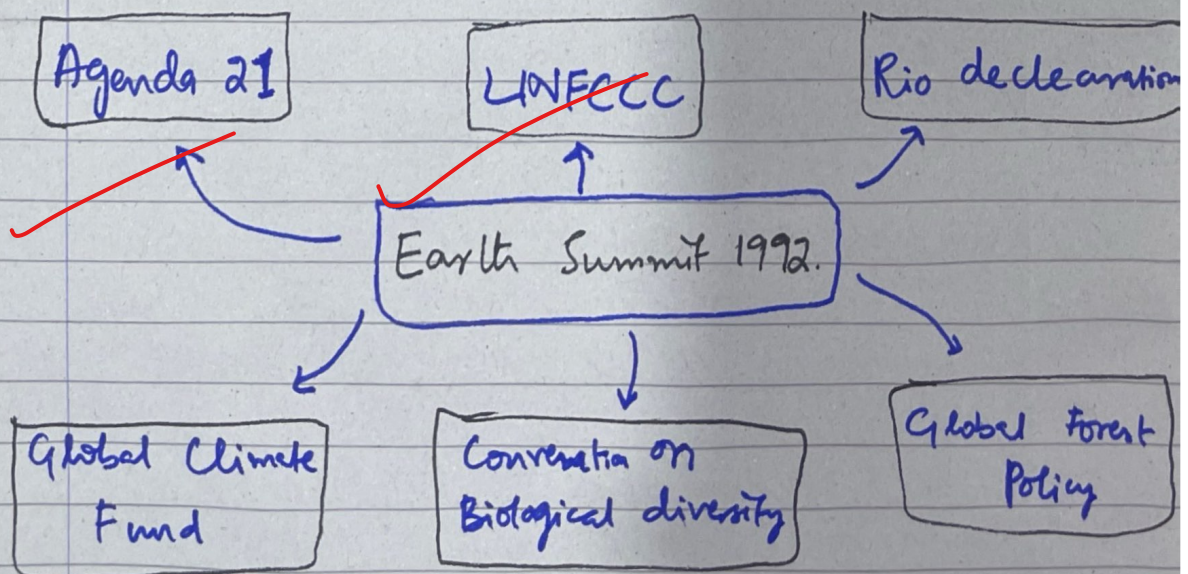


(A) Explain the Products of Earth summit of 1992?

Because of its key steps such as Agenda 21, Rio declaration, and UNFCCC, the Earth Summit has an place in mitigating the climate impacts. Moreover, this conference was attended by 192 global leaders highlighting its significance.

### 2. Products of Earth Summit 1992:

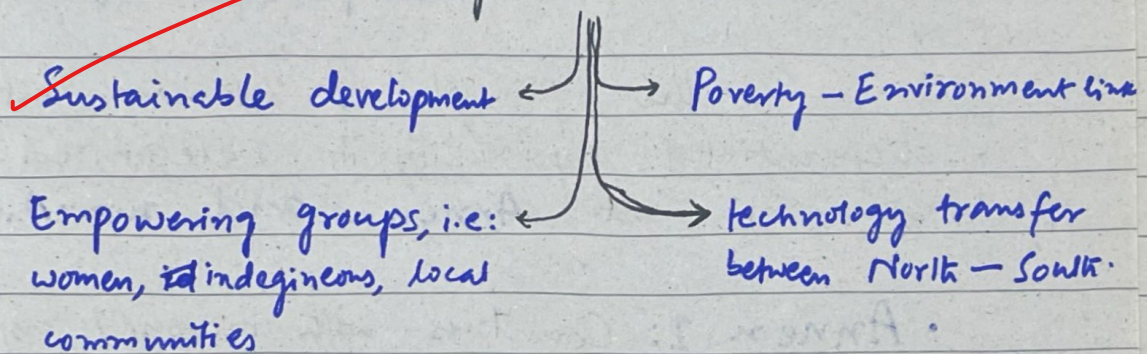




## 2.1: ~~Agenda 21~~:

Agenda 21 is a non-binding global action plan to mitigate the impacts of climate change through action plans that are tailored to local, regional, and global needs.

Its provisions:



6400 local action plans have been implemented to this day.

## 2.2: United Nation Framework convention on Climate Change:

UNFCCC is a landmark multilateral agreement between countries.

Its ~~primary~~ aim was to reduce greenhouse gas concentration and stabilise them. For this, it gave several principles:



## Principles:

→ P2: stabilise GHG.

## Principles:

→ P3: CBDR and sustainable development.

→ P4: Obligations; mitigation, adaptation.

→ P7: COP as a supreme body.

On the principle of common but differentiated responsibility, it categorised countries into Annex and non-Annex:

• Annex 1: Countries with increased responsibility.



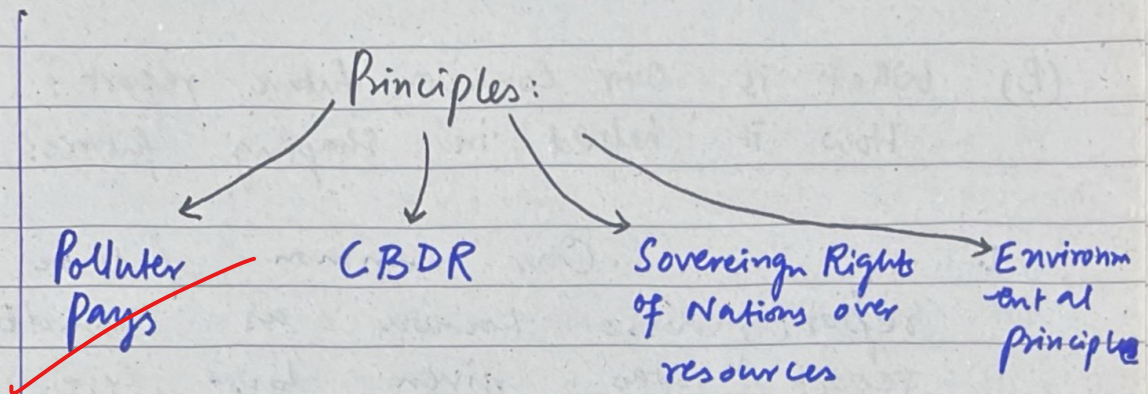
Subset of Annex 1: Countries that will develop countries through technological transfer and funding.

• non-Annex: Non-developed countries with less responsibility.

## 2.3: Rio declaration:

The Rio conference passed a declaration with 27 principles to combat climate change.





#### 2.4: Global Climate Fund:

Rio declaration also established a global climate fund to help transition developing countries. It was latter formalised under the UNFCCC.

#### 2.5: Global Forest Policy:

The Earth Summit 1992 was the first conference to give a policy on forest resources of the world.

#### 2.6: Convention on Biological diversity:

The Earth Summit 1992 highlighted the innate value of Earth's living organisms that are living on it before humans. It established mechanism for their protection.

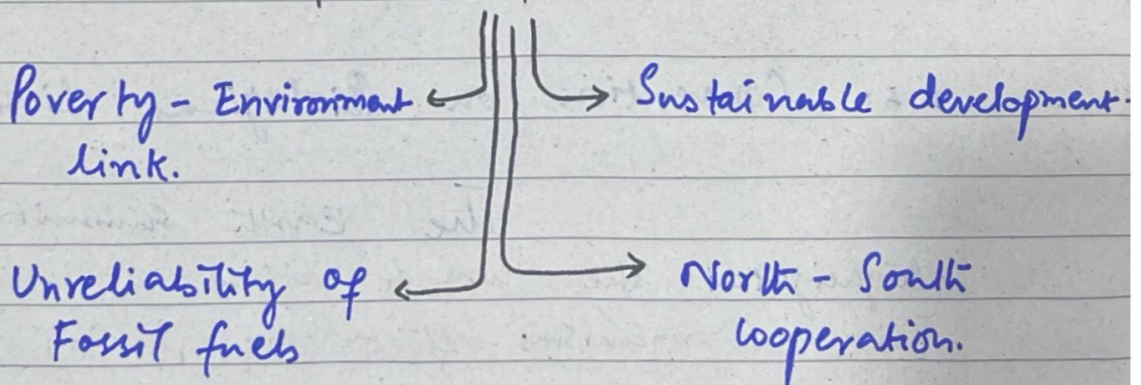


(B) What is Our common future report?

1. Our common future report, also known as Brundtland report, was given by Gro Harlem Brundtland (Norwegian PM), on the recommendation of World Commission on Environmental Development, UNGA.

The aim of Brundtland Commission was to track global environmental development since 1972 Stockholm conference and evaluate the challenges of in environmental management.

1.1: Poverty - Environmental linkage:

Our common future report



linked poverty with environmental damage. According to the report, poverty leads to excessive exploitation of resources.

### ~~1.2: Defined sustainable development for the first time:~~

The Brundtland report gave the definition of sustainable development which is growth without harming future generations or intergenerational equity of resources.

### 1.3: Unreliability of fossil fuels and conversion to renewables:

~~Our common future report~~ emphasized the conversion to renewable energy resources because of the 1970 oil crisis.

### 1.4: Enhancement of global cooperation:

The Brundtland report emphasized global cooperation for effective climate change mitigation and adaptation.
