His efforts helped Muslims to recognize their identity as separate nation which later became the basis of Two-nation theory.

## Historical Background:

After the death of Aurangzeb in 1707, downfall of Muslims started and whose cracks became deeper with time. Islamic teachings were fading from Muslims and their mental intellectual capability was deteriorating. Identity of

the Muslims were compromised. Muslims had innovated many things (biidat) in Islam which was hurting their social and moral value. Economic conditions of Muslims was pathetic because of high taxes. Because of the downfall of Muslims many regional powers like mughals and sikhs were arising which threatened the identity of Muslims. This was the time when social, political, religious and economic conditions of Muslims were rotten and need to be revised.

## Introduction of Shah Waliullah:

Shah Waliullah was the man of power who raised in the rise and give direction to the Muslims to improve their situation. Shah Waliullah born in 1703 in Delhi. He got his early education

from Madrasa-i-Rahimiyya founded by his father Shah Abdul Rahim. Later in 1923 he left for Arab for further study in Ahdeess and Islam. When he came back to sub-continent, he saw the conditions of the Muslims and started to work for improving it. He worked for improving their conditions from social to economic.

## Socio-Political Reform:

## Religious Reforms:

decided to translate Islamic teachings in regional languages.

### **Persian Translation of Quran:**

He translated Quran into Persian language for its better understanding by people.

### **Emphasis on Ijtihad:**

He emphasis great focus on ijtihad for the religious matters to tackle bidats.

### **Educational Reforms:**

Besides religious reforms, he also focused on the education of Muslims. He opened many branches of Madrasa-i-Rahimiya for the education of Muslim. Later on, it become the great source of knowledge, and first Urdu translation of Holy Quran was also published from it. He also taught many students to <sup>with</sup> different Islamic knowledge which were also assets for Muslims.

## Economic reforms:

Along side, ~~Economics~~ shah walli ullah also analyzed the economic situation and concluded that major stress on finances of state was the ~~people~~ who get the pay while ~~doing~~ nothing. On the other hand, high taxes were imposed on merchants and farmers. So, he ~~advised~~ advised government to reduce taxes, so economic condition can improved. He also advised Muslims do not do dishonesty in purchases.

## Impact of shah walli ullah movement:

### Intellectual capability was revived:
