

# CONTEMPORARY CHALLENGES OF THE MUSLIM UMMAH AND THEIR SOLUTIONS ACCORDING TO THE TEACHINGS OF ISLAM

## According to Hadith:

The Prophet Muhammad (P B U H) said:

"The believers in their mutual kindness, compassion and sympathy are just like one body. When one of the limbs suffers, the whole body responds to it with wakefulness and fever."

(Al-Bukhari and Muslim)

Recent conflicts in Middle East countries like in Iran, UAE, KSA, Kuwait, and Qatar highlight the consequences of political and sectarian divisions in the Muslim world.

## ISLAMIC SOLUTION:

### **According to Hadith:**

Holy Prophet Muhammad (PBUH) said:

"Each one of you is a shepherd and is responsible for his flock."

(Al-Bukhari and Muslim)

**Abul A'la Maududi** in **Islamic Law and Constitution** argued that Islamic governance should be based on accountability and consultation.

Ibn Khaldun in his famous book **Muqad-dimah** emphasized that justice is the foundation of stable civilizations.

### ISLAMIC SOLUTION:

- Establish justice based governance.
- Promote transparency and accountability.
- Implement the Islamic concept of **Shura** (consultation).

## 3) EDUCATIONAL AND SCIENTIFIC

- Encourage innovation and intellectual revival.

## 4) ECONOMIC INEQUALITY AND

### Solution:

Promote interfaith dialogue.

Use media and education to spread the true message of Islam.
