Pakistan's population is equivalent to 2.99% of the total world population, fixing the country on number 5 in the world (Worldometer elaboration of UN, July 2023). Simultaneously, the country's annual population growth rate is 1.8% which is directly proportional to the unemployment rate.

This number of migration is increasing day by day. When unemployment increases, the GDP and per capita income decreases, resulting in low standards of living, depression, misery and crime (IRASD, Journal of Economics, November 2023).
