China's rival India is also making progress and China is pursuing trade with India bilaterally without any contention. China is embracing its role through diplomatically by stabilizing the region through talks and negotiations instead of war which can be dangerous for the world.

All the national and provincial institutions should follow and implement the national policy. They should follow the constitution of Pakistan which is the extreme law of country. They

should prevent themselves from their monopoly. If they do not follow the constitution and national policy, they should penalized which create deterrence for others.

ii) Eradication of Social problems

Social problems such as poverty, injustice, unemployment should be eradicated from the society. The children of rural should provide opportunities to go to school. The justice should be established. Poor and rich will be equal before law. No discriminability should be made between poor and rich. The youth should provide with employment and other projects for their betterment and encouragement.

iii) Cope with Terrorism

The evil of terrorism which is haunting every sector, every field and every section of Pakistan should be cut down. All possible efforts should be made to make pakistan terrorism free. The zero-tolerance policy should be adopted against terrorists. Special care should be

put on the safe places of terrorists to destroy them. Global help should be asked to eradicate this evil from society.
