- Unless limited do not limit your argument to specific segment.
- Specify one effect in topic sentence.

Topic Sentence	Do not use contractions Govt's neglected towards unemployment results in far reaching socio economic effects in youth.
Explanatory or Reasoning sentence	lack of education, skills, job opportunities and inflation is creating alarming situation.
