## Hybrid Warfare: Threat to Pakistan's Security

Pakistan has been vulnerable to its security challenges since its inception. In contemporary world, Pakistan is vulnerable to insurgency, information warfare, militancy, cyber attacks, economic strangulation, misinformation etc.

- a) Destabilize Pakistan
  - b) Economic instability.
  - c) Portray negative image of Pakistan.
  - d) To weaken Pakistan internally.

## Hybrid campaign against Pakistan

Pakistan is facing multi-facet security challenges. Such challenges are increasing day by day - due to Pakistan's ~~security~~ geo-strategic position. Cyberattacks are more frequent now. Following are few examples against Pakistan in which enemies are frequently engaged in hybrid campaigns.

### a) Command and control system of Pakistan's Nukes.

Pakistan has developed its nukes and it is a responsible state. Pakistan has effective control and command system. Pakistan's command and control system is in accordance with **IAEA** guidelines.

However, international media and scholars have overstated their concerns regarding Pakistan's nuclear weapons. There is propaganda that nukes may fall out in the hand of terrorist organization which is merely a propaganda against Pakistan.

### b) Conspiracy against Pakistan and China economic corridor.

Western media has developed narrative that CPEC will increase theft cases, terrorism, drug trafficking in the Pakistan. They regard this project as "debt-trap." Adversary has been using militants to halt CPEC project. One of such example is, attack on Chinese consulate in Karachi.

c) Exploit Balochistan's youth to destabilize Pakistan.

India has been employing hybrid warfare against Pakistan. India is funding different groups in Fata Balochistan to disintegrate Pakistan. The arrest of Kulbuschan Yadav in Balochistan, the confession made are real manifestation of Indian hybrid warfare design against Pakistan.

In addition to this stock exchange incident is a direct attack on economic setup of Pakistan. This attack is conducted by Balochistan Liberation Army (BLA) that ~~was~~ is funded by India to create unrest in Balochistan.

#### d) Portray negative image:-

Indian Chronicles report by 'Eu' shows that a network of 500 fake media outlets had been used by India to portray negative image of Pakistan.

#### e) Accusation of Pathankot attack

India accused Pakistan for Pathankot attack without any meaningful evidence. Such accusations not only present Pakistan as terrorist state but also damage its soft power.

#### f) Pakistan: safe heaven for terrorists.

India internationally, blame Pakistan for terrorism. In order to damage reputation of Pakistan, it is involved in propaganda so, to improve its diplomatic standing in the world.

#### g) Lobbying in FATF

Moreover, lobbying in FATF, to get Pakistan black-listed clearly identifies India's political and military leadership goal and objective toward Pakistan, an indirect war

Strategy against Pakistan on the international stage to seize its economy and assets.

b) Incite Sectarianism in Pakistan for one's interest.

Pakistan is multi-ethnic country. Attack on Huzara Coal miners by IS group increases tension between government and aggrieved community. Proxy war which Pakistan has been victim also incite sectarianism in Pakistan. Saudi-Arabia supports Sunni Section and Iran supports Shia Section of Pakistan for their rivalry. Middle East rivalry has proliferated in Pakistan resulting in disharmony, violence and mistrust.

(i) To degrade Pakistan prestigious institutions:

India disseminate misinformation to instill hate in public. Pakistani institutions are special focus of such malicious propaganda.
