in developed countries. This cultural

and social integration is result of

globalization. It has eroded the traditional

that globalization ^{is shown} has increased the

Also, ~~globalization~~ has increased
the economic development of developed
countries more than developing countries.
Due to advanced technologies and
mass production of goods it has
converted their economies from deficit
to surplus. For example, Chinese economy
has shown major surplus in its
economy like its Gross domestic
product has amounted to around
\$ 18.1 trillion ~~and it stood at~~
number ~~second~~ ^{China does not classify as developed.} in the world after US.

It can be said, that globalization
has the capacity to boost the
economy of developed as well as
developing countries if its tools are

used properly.

The other factor that affects globalization is that it has promoted free movement of people across borders. As the concept of globalization means borderless economy that has increased the flow of people in developed countries. This free flow of movement has promoted immigrants and refugees from one country to another country. For example, the Russo-Ukraine war has displaced almost 20 million people and almost 10 million has left the country due to war threats. Therefore, globalization has contributed to free flow of people across borders in developed countries.

The globalization has not focused to completely transfer the advanced technology to developing countries. Still in 21st century, the half of the global countries are out of the reach of advanced technology. The developing countries are

unable to acquire the advanced technology that has resultantly led to their less production and remain on global south of the world. Therefore it is liable on developed countries to help the developing countries to acquire advanced tools so they can also contribute to global economy.

Moreover, due to globalization developing countries are becoming trade deficit as compared to developed country. This is because they have still not acquired the advanced tools in order to become trade surplus. Taking example of Pakistan; she is facing economic challenges like current account deficit, fiscal account deficit. ~~These~~ challenges like decrease in exports and increase in imports. According to world bank data of 2022, Pakistan's exports were (10% of GDP) and imports were (17% of its GDP) that has led the country to trade deficit. In a nutshell, it is important for developing

countries to acquire advanced technology if they wanted to increase their production.

On the other hand, globalization has increased the social and cultural values to disintegrate. ~~From~~ Due to transfer of goods and products our traditional values and norms of the society has eroded because of introduction of technological products and products. The increase of western culture ~~is~~ in developed countries and mobile phone use has totally changed the social and cultural norms from traditional to modern ones. This shift has contributed more in the disintegration in the society of developed countries.
