3- Education For Both People and Leadership:

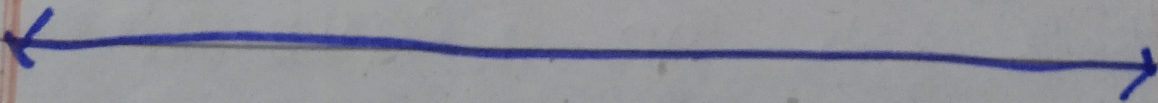
Education necessary for both voters and leadership and the representatives of the people. if they are well educated they

the charismatic leadership of china also developed China. Xi ping policies of construction and investment in other countries. Also developed China. Because they invest in other countries both side are benefits.

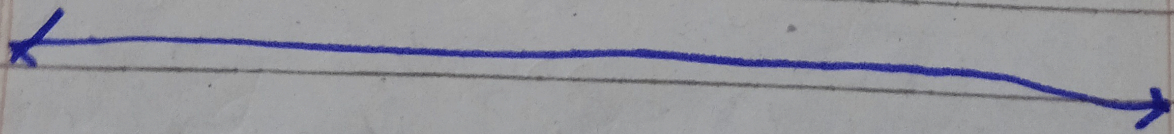
5- Hard Rules Against Corruption:
