But, in case of developing countries like Pakistan, it is a liability. As the country is faced with plethora of socio-economic and political crises, youth bulge is a curse in this regard.

The country population reaches 241.5 Million with a growth rate of ~~2.55~~ % (percent) as the 7th digital census concludes (Pakistan Bureau of Statistics, 7th Digital Census, 2023).

Besides, according to United Nation and USA census Bureau, Pakistan has become the 5th most populous country of the world, while 45th largest economy of the world. This shows the grim picture of the country's situation.

Therefore, youth bulge, despite being valuable, is currently a liability due to challenges related to scarce resources, deteriorated economic conditions, political instability, poor education and healthcare systems, unemployment, brain drain and so on.
