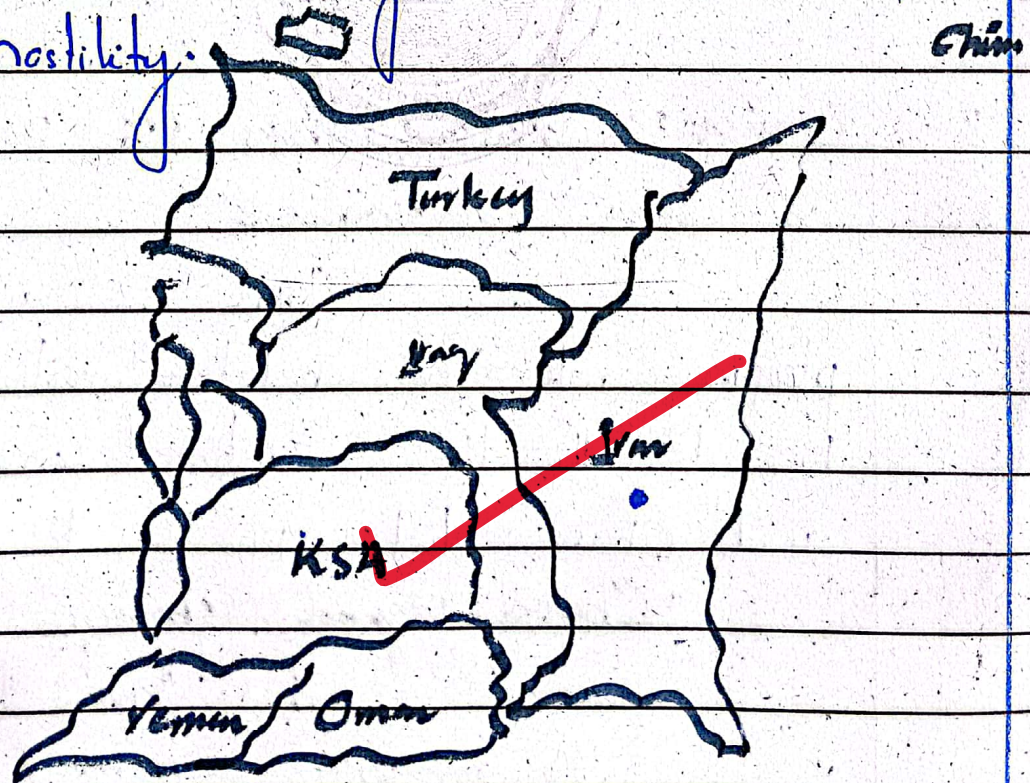

China is a main player in KSA-Iran negotiation. In fact, China led to both houses of KSA, and Iran to come on a single table.

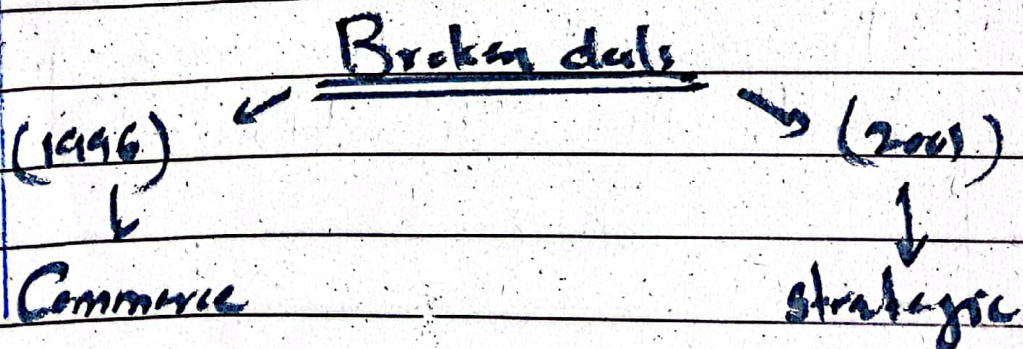

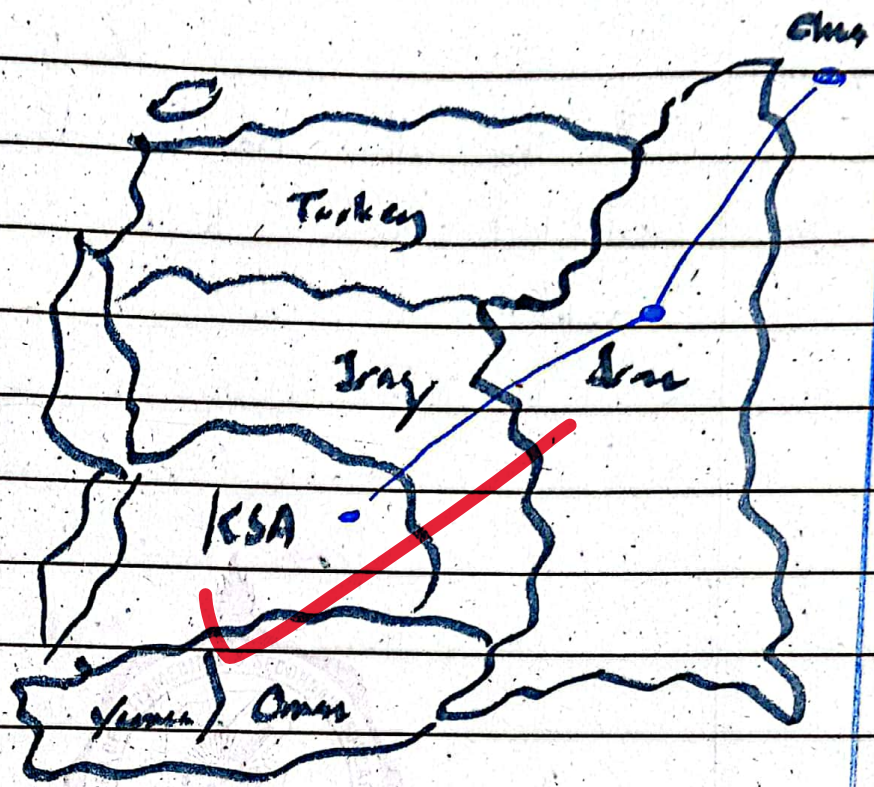

Therefore, the USA has own concerns with rest of all.

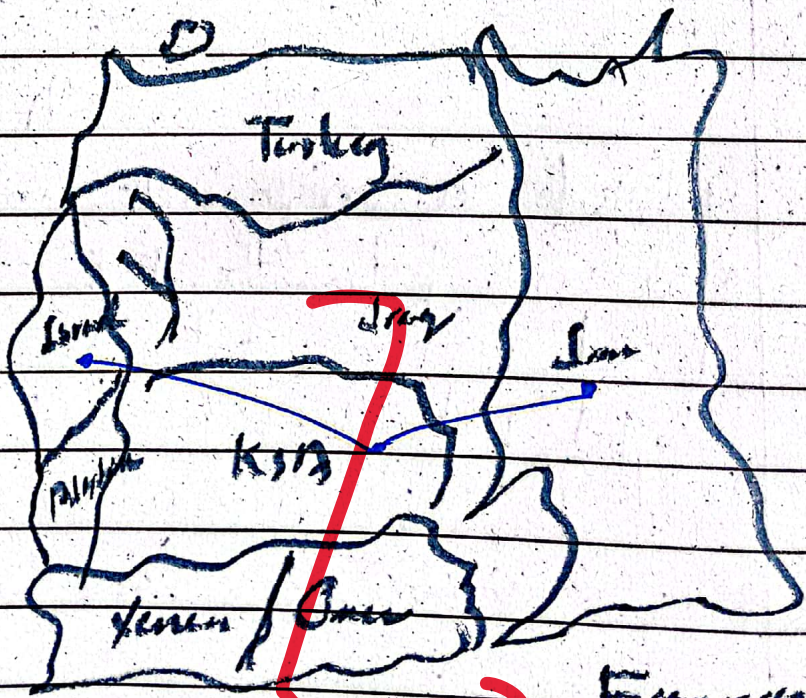

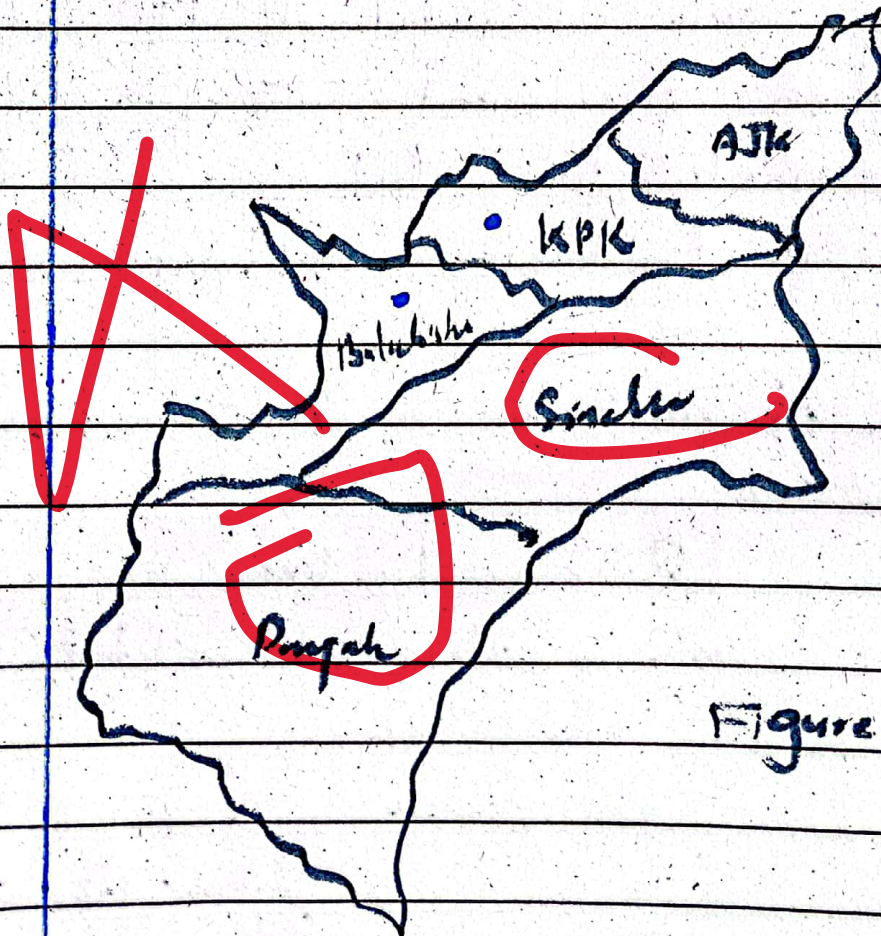

(Pakistan Bureau of Statistics, 2022)





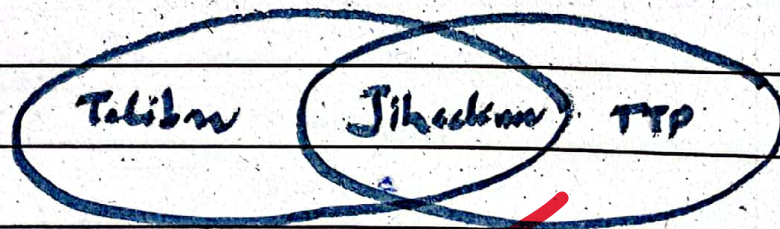
Thus, Taliban government encouraged TTP.

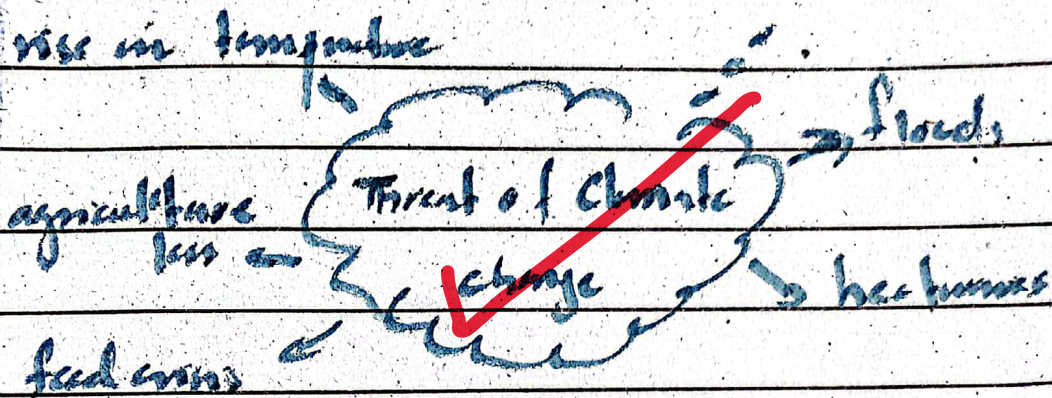
2. Climate changes: A real threat

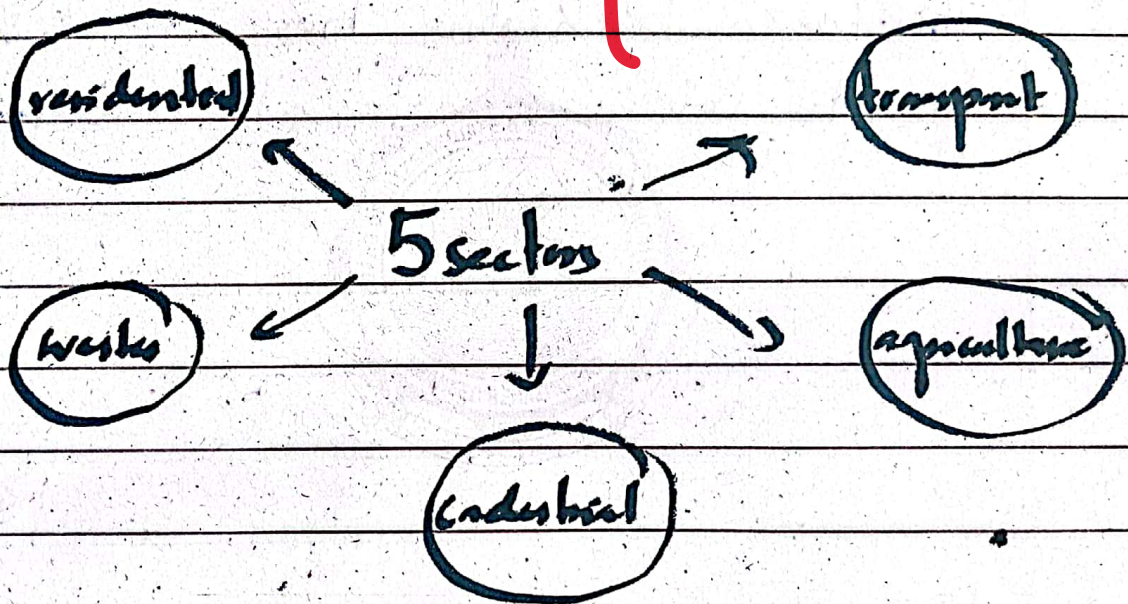
