1. Introduction:

Apart from other religions Islam is the only religion which gives proper due rights to its minorities. This example is unmatched by other religions. It gives them the right to worship freely, trade, get education. Similarly, Islam also protects the minorities from intruders.

2. Rights of Minorities in Islam:

Islam ensures provision of several due rights to its minorities. Following are some rights which are duties on Muslims.

A. Right of safety from invaders:

Islam takes a safety tax from dhimmis (minorities). In return gives them guarantee of safety of life and property. As Zakat is not taken from minorities, therefore safety tax is mandatory on minorities. There are many examples in which Muslims returned the safety tax to minorities when sensing the failure to protect them. Like one in time of Hazrat Ameer Muawiyah.

B. Right to worship freely:

None any religion gives this right to its minorities to worship independently. This is the only religion which ~~gives~~ bestows them this right.

During Misaq, Madina (part of Madina) Muhammad (PBUH) allowed them to worship freely. Even they were given right to drink wine. But in later condition the wine should not be brought in front of Muslims or Muslim territories.

C. Right to trade:

permission of trade was also

allowed during pact of Madinah. They can trade, own business with each other and as well as with Muslims and other people. Islam does not hampers them from free trade. It does not imposes a sanctions on them.

Minorities are free to establish their own educational institutions and get education. State also allocates funds for ~~them~~ their institutions, so that they can acquire knowledge.

(a) Charter of Madinah:

Charter of Madinah is considered as the first written constitution in Islamic history. It was signed by prophet Mohammad (PBUH) between Muslims (Ansar and migrants) and Jews of Madinah. It is, actually, an agreement between the Muslims, Jews and all those

who were residing in Suburbs of Madinah. It contained around 57 articles. The main objectives and articles of charter of Madinah were as follows.

1. All Muslims and Jews will ~~live~~ live freely in Makkah without interference of each other. There will be no conflicts between them, and peace is promoted.

2. All people are free to abide by their own religion. They are free to worship. And no one will impose his religion on other.

3. If someone - foreigner - invades Madinah, all people will act accordingly for the safety of Madinah. Whether the invasion is on Jews or Muslims.

4. Jews are free to trade and own their business. They can drink wine, sell and purchase it. But it should

not be reached in Muslim market.

5 Everyone is equal before law whether it is a Muslim or Jews. However, cases of Jews will be proceeded according to their own religion and book.

1. Prophet's hadith about education:

2 prisoners during Badar Battle:

Around 70 disbelievers were arrested during the battle of Udd Badr. Which were kept in Madinah for a few days. Some were released on payment condition while the rest who could not pay for their acquittal, were made to teach the children of Madinah. It is worth noting that prophet (PBUH) ~~can~~ could release them on other conditions. But he preferred education over all the others.

3. Subba: a nursery for scholars:

importance of education can also be witnessed from the fact that a small place was established inside prophet's Mosque, called Al-Subba. This was actually a nursery for knowledge seekers. People used to come to quench their thirst of knowledge. Apart from Quran^{and} Hadith, Sharah philosophy, Fique and business knowledge were the key subjects. These scholars were then spread to other parts of Makkah and Madinah to impart knowledge. ~~Starta~~ For instance, Hadrat abu Huraira is one of the scholars and alumnus of Subba.
