But, United States of America, China, India and many other States are not achieved required target; (Planete-energies.com, Article, 2021). So, States are not meet their targeted carbon reduction or emission.

Second, Carbon trading is major hurdle in the de-carbonisation. Developed states buy the quota, of the usage of carbon, of developing States. There are 38 states, who use carbon trading and increase carbon emission. In 1997, Carbon quota added to every-state in Kyoto, Japan but the agreement is not stop carbon trading it only stop or fixed usage of carbon to every state. Resultantly carbon trading is also the hurdle for climate change.

Third, The financial contribution were decided for 3rd world States of effectives of climate change in Copenhagen, Denmark, 2009. This is for effectives of flood, disasters, and other

Disaster that are caused by climate change. Developed States take responsibilities of damages that are caused by climate because they are contributors. For example, the specific figure of amount at COP-21 is 100 Billion dollars and out of these 24 Billion dollars only by USA in 5 years. But, the financial contribution was short by 22 Billion dollars. In which 13 Billion dollars less given by USA. Therefore, ~~negligence~~ negligence of given fund by developed states also badly affected to other states.

Further, Deforestation ~~among~~ is still an obstacle for States because due to rise in temperature fire started in forests. Wild-fire is the biggest cause of deforestation now a days. In 2020, Australian forests burn due to wild fire. Consequently, Deforestation is still hurdle for States.
