Choice for adoption of political systems for Taiwan:

In the middle of the twentieth century, when ~~Israel~~ Jews formed their separate state by the name of Israel, they started working on its consolidation. They furthered a fierce propaganda against Palestinians in order to legitimize their occupation of Palestine. A campaign was launched in order to project Palestinians as aggressors.

Moreover, they projected Hamas, a political organization, as a terrorist organization equal to ISIS. Palestinians have been projected as terrorists and in turn tagged them as "unhumans."

In order to legitimize Israel, they projected history, according to their own standards, projecting Palestinians as an aggressive force against a peaceful and progressive Israelis. Hence, the state of Israel tried to legitimize its nation-state by ~~projecting~~ Palestinians dehumanizing and de-historicizing Palestinians.

Regional Implications of Israel-Hamas war :

- 1) Strained Relations of Israel with the middle-eastern countries

The ongoing conflict entails consequences on regional politics. Some middle-eastern countries were on the verge of recognizing Israel, however, the growing conflict has insignificant political relationships among these actors.

2) Rising Block Politics in the Region

Moreover, various actors are looking for China to use her influence to phase out possibilities of a longer war. China, with her prospects of peace-maker, is rising as the greatest regional actor.

3) Discourse formation against Israel

Various countries, especially Muslim and western countries' majority, can be seen as sympathizers of Palestinians. A new discourse is under formation. This could dent Israel's standing and the US's standing on the international arena, which could pave the way for the rise of actors like China and Iran in the region.

Global Implications of Israel-Hamas War:

1) Polarization in Global order

The ongoing conflict has the potential to polarize international order as various actors' stance is opposite to each other. US and its some allies are supporting Israel, on the contrary, some are supporting Palestine. The issue is already intensification the debate on various forums. Hence, it could polarize the international world order.

2) Possibility of a large-scale war
