INTRODUCTION:

The cold war era remained intact for almost five decades. Two different ideologies - capitalism and communism - fought cold war to dominate political and economic spheres. It was not until 1990, that the fall of Soviet Union ended the long cold war. US rose as the sole superpower. Various theories define and calculate different causes that led to unexpected end. Contribution of these theories are of paramount importance.

BACKGROUND OF COLD WAR:

With end of world war II, two super powers held



dominance over globe - Soviet Union and the USA. Both the powers had different ideologies and different economic structures in mind. This war is called cold because the two parties never came into direct conflict but fought proxy wars. Vietnam war, Korean war and Afghanistan war are few examples.

It was Nikita Khrushchev that realized the deteriorating internal matters and decided to end the war.

THEORETICAL EXPLANATION

Surprisingly, traditional theorists failed to explain the end of cold war and new theories had to emerge on the horizon. Such are the contributing theories

1: Neo-Liberalism: Liberalism has always account for peaceful co-existence in international arena primarily following principle of neo-liberalism explain peaceful end of cold war:

a/ The reciprocity principle: Liberal theories are strong advocates of reciprocity where one positive gesture can lead to simultaneous gestures.

The Cuban missile crisis is an example where the two powers were on the brink of war when USSR pulled the naval ships filled with missiles and US reciprocated by excluding missiles from Turkey.

b/ Collective security: Both powers prioritized global security fearing that global arms race could prove to be devastating for humanity.

The agreement of SALT is an example of arms reduction globally. Until February 2023, START which is successor of SALT remained intact.

2: Post modernism: The theory emerged as a consequence of failure of traditional theories to explain the peaceful ending of cold war. It is a literary theory and based on critics. It explained through following discourse

a) Belief and facts: The theory argues that belief and facts are objective inculcated through dominant discourse. It was argued that USSR and US were rivals yet it was recently that both countries fought against Germany together

b) The power of language: It was the people that forced the end of cold war on both sides. Public opinion have great impact. The opinions were against the war thus both initiated the end.

c) Dominant discourse: The idea is spread through elites. It was deemed that Russian satellites were part of Russia which cannot be separated. However, this discourse proved to be ineffective as all the satellites secured independence as soon as USSR fell.

d/ Elite create valid knowledge:
[Post modernist argument that the knowledge is construct For instance, it was argued that nuclear war was inevitable. However, through mutual cooperation. The world was secured from the emergence of nuclear war.

3) Constructivist approach:

Constructivism accounts that the nation-state and international system is constructed. There persists no reality. The world is shaped according to the interest. In case of cold war, constructivist argues in following manner.

a) The world is socially construct: The polarity of world and structure are socially constructed. It is usually argued that the type created by the US was impracticable as there was no actual comparison. The fall of USSR and the end of cold war is the proof of this construction.

b/ Agency and structure:

There is no unitary actor in the world, each actor - individuals, institution, state and culture, plays dominant world. It was the agency of people that raised anti-war sentiments and the war had to end.

c/ Identity constitute interest:

USSR was portrayed as an economic giant. The internal happenings was not known due to authoritarian regime. This identity compelled USSR to secure global influence as being super power. However, as soon as this identity vanished, the expansionist sentiments also fell leading to peaceful end of cold war.

CONCLUSION:

The end of cold war was a reality check about the unpredictability of state behaviour. Theories of constructivism and postmodernism denied any objective reality which paved the way for possibilities in dynamic manner.

INTRODUCTION:

The growing Chinese influence in Persian Gulf is the indication of revival of multipolar international system. Until recent past, Iran and KSA were hostile states that have fought several proxy wars. There was no mediating effort from the part of USA to reduce the hostility. With the Chinese leader taking the measure it has reflected on the fading influence of America and rise of multi-polar world.

BACKGROUND: Relation between Iran and KSA deteriorated following Iranian revolution. The monarchic system was brought down in Iran and theocratic system introduced. The threat of the spread of revolution and toppling off of monarchy in KSA became stumbling block in their relations.

1: Historical achievement:

2: US role as global

5: Inclusion of Iran and KSA in BRICS:

Iran and KSA have become full members of the leading economic platform. Being oil rich giants, these countries can change the dynamics of influence. America and western powers are dependant on oil, this tilt can prove to be a serious blow.

6: Diversifying economy:

In order to ensure self sufficiency and independence, KSA has taken measures to diversify its economy. For this it is looking towards Chinese government. Hence, reduced reliance on US which manipulates it for its self interest.

CHINESE DIPLOMATIC POLICY

The growing popularity and influence of China can be analyzed by its principles of foreign policy while dealing with other countries. which is called Panchsheel. It follows strictly five principles to deal with countries

1: Non intervention: China do not interfere or intervene in internal matters of states as was in case of America.

2: Respect to sovereignty: China respects sovereignty of each state and expects the same gesture from other countries.

3: Mutual - co-existence: Chinese government strives to establish a conducive milieu where states live peacefully without any threat

4: Non aggression: China do not prefer using force and avoid

mallo, which could lead to was.

So mutual cooperation: Under the BRI project, China is seeking for economic development of backward countries by connecting Asian, African and European market.

Under these policies China is an advocate of welfare, cooperation and development. While on the other hand America followed carrot and stick policy which was not encouraged by most of countries.

CONCLUSION:

For decades, the status quo of unipolar world was unkindness under coercion policies of America in economic, political and social spheres. However, the mediation of Iran-Iraq war at the hands of China is a proof that China has dominance influence over global politics and has become a power. 2: Extreme form of

nationalism: European fascist
movement was the result of extreme
form of nationalism. The defeat in
WWI and humiliating treaty of
Versailles was a scare for Germans. They
wanted to reduce this humiliation.

Similarly, Under BJP government, India has fanned the wave of extreme form of nationalism which is threatening for minorities.

3: One man authority:

All the decisions were made at the hands of one single leader in fascist regimes without any accountability.

In Indian case, it secures a BJP dominated government where he is the decision maker.

4: International reaction:

Both Mussolini and Hitler violated international law and seized various areas. Millions of people were massacred. There was no distinction between combatants and non combatants and the international community was silent. Global community is silent even today. People of Kashmir are killed, tortured and disappeared and there seems no accountability.

Assess the impacts of Russian-Ukraine war

INTRODUCTION:

Despite completing one year, no possible solution has been offered to growing Russian-Ukraine war. Even the global super power is incapable of influencing global community to bring about possible solution. This is an indication of fading influence of America in face of uni polarity. The conflict has paved the way for series of measures taken by countries to reduce western dominance in global sphere. In fact, multi polarity is not a buzz word, it has become an existing reality.

IMPACT ON FUTURE OF UNIPOLARITY:

1: Declining dollar diplomacy:

Under growing sanctions of western powers, many countries have decided to pursue trade in their local currencies instead of dollar.

Dominance of US on economic sphere is due to dollar diplomacy and currency used as foreign reserves. Ultimately dollar would be replaced from economic market threatening unipolarity.

2: Growing Regionalism:

States have realized that capitalism is new sort of merchantilism where US and west exploit developing countries in exchange with finished goods. For the purpose, states have adapted to trade regionally more cheaply. The impact of war on global supply chain was an eye opener.

Merchantilism was securing mother land's interest in global sphere. Capitalism has the similar aim.

3: Block politics: In order to secure their economic and political interests, countries have started to come together in groups. Recent expansion of BRICS was the result of Russian-Ukraine war when Russia was sanctioned under western powers.

Realist perspective: The balance of power phenomenon has brought the converging interests together threatening unipolarity of America

4: Fading influence: Failure to bring about possible solution to Russian-Ukraine war has impacted the credibility of US as global power. In fact, it is engaged in indirect support through supplying arms and ammunition. Resultantly, war has escalated to a longer term.

Realist perspective, state as rational actor: US is well aware of the fact that direct engagement in war could lead to nuclear war. Therefore it is acting indirectly. This measure is impacting the unipolar HHe of US.

5: Geopolitical Impacts:

Inability of US to mediate between Russia and Ukraine has paved the way for Chinese diplomacy. Recently China achieved remarkably victory by mediating between Iran and USA.

The reciprocity principle:

Realist argues that state reacts as a cent acts. China is engaged in diplomating efforts to bring Russia to possible agreement. If it secures this mediation, it would be a serious blow to unipolarity.

6: Power politics: Under

the threat of expansionist Russia, many eastern European countries have become a nato member. Adding members from neighbours of Russia in nato could only make the matter worst. Russian threshold is membership of Ukraine in nato.

This would be the last nail in the coffin leading towards catastrophic war. For sure, the unipolar status would be vanished.
