South America (Argentina) have been accepted in BRICS. Formerly 14 countries had applied for becoming a part of BRICS. among those, ~~and~~ Only six countries were accepted. BRICS has welcomed a regional hegemon of Middle East, KSA which has a huge economy of \$19.3 tr. This expansion is going to have far reaching geo-economic and geo-political impacts.

• Geoeconomic and Geo-political Implications of expansion of BRICS:

i) Addition of Major Economies:

Egypt being second in Africa is a flourishing economy that has been welcomed to BRICS. Similarly, the addition of Iran, KSA and UAE from Middle East has expanded the overall economic share of BRICS in global economy.

ii) Bringing Adversaries on Table:

Despite the tensions in relations of Iran and Saudi Arabia, they both have joined BRICS which may lead to betterment of relations among both states. A recent development in improving relations among both adversaries is China's assistance in normalising relations. It is a major geopolitical gain that will benefit BRICS.

• Hurdles and Obstacles for BRICS:

i) Divergence of Interests of major Powers:

The increasing collaboration of US and India has lead to reduce the Russo-Indian closeness. Although, India has remained neutral on Ukraine war but still India's increased US affiliation can result on impact badly on BRICS.
