Introduction:-

Zakat is one of the five pillars of Islam and it is an obligatory act of worship for all Muslims who meet the necessary criteria. It is a form of charity that is paid one on a monthly basis. The purpose of Zakat is to purify one's wealth and help those who are in need.

1) Zakat - Philosophy of Spending in Way of Allah:-

The Muslims believed that Zakat is the spend in the way of Allah from He has given them. God also emphasized that Zakat is the spending in the way of Allah. According to Quran,

"Those who spend their wealth in the cause of Allah, and do not make a show of their charity, nor hurt anyone, their reward

is with their Lord. They shall have no fear nor shall they grieve"

Quran 24:38

There are two types of spending. One is called Zakat, it is obligatory on those who can afford it. The other one is Sadaqa, it is not obligatory.

2) Literal and terminological Meaning of Zakat:-

The Arabic word Zakat that means that "purification" and "growth". The Zakat literally meaning is the purification of one's wealth.

3) Zakat Increases Wealth:-

Zakat has increased wealth because Zakat is the spending in the way of Allah.

Surah Saba Verse 39 emphasizes that those spend in the way of Allah, Allah will replace it.

4) Purposes of Zakat:-

i) There are two ownerships

of wealth, one is Real ownership that belongs to Allah because He is the Creator of all universe. And the Second ownership belongs to a servant who own the property that transfer by God. It is necessary to person use this wealth for humanity, not used in foolish purpose.

- ii) Muslim believes that property is a blessing for which God deserves praise and gratitude. It is an investment which encourage work and promotes growth through zakat.

5) Quran Emphasizes the Zakat:-

"And keep up prayer and pay the poor-rate and bow down with those who bow down"
Quran 2:43

"And whatsoever charity you expand, or vow you make, Allah knows it all and for the unjust there are no helpers"

Quran 2:110

6) Payment of Zakat:

Zakat is payable once a year on gold, silver, cash, cattle and goods used for trading purpose. This rate in the case of cash amount is 2.5 percent of the total amount in hand at the time of payment. In the case of gold and silver, the rate is also 2.5 percent of the total current value of the gold and silver.

Impact of Zakat on Human Life and Society:-

Spiritual Impact:-

i) Zakat Removes Greed from Human:-

The first and foremost purpose of Zakat is to remove the greed from hearts of the believers. It aims at creating the love of God in hearts. It creates Taqwa

"Surah Lail highlight the spending of money make clear human"

2) Zakat Removes Love of Materialism :-

The real enemy of the man which keeps him away from religion is the love of the world.

3) Zakat Bring man Closer to God:

It brings one closer to God as it is a source of great reward

4) Purification of Soul:-

Zakat relates to a person's individual capacity. The giver gives his heart from greed, and acquires fear of God.

Allah Said,

"He shall be saved from Hell fire who is God fearing and who gives riches to other for the purification of his soul"

(Quran 92: 17-18)
