Purpose of Aligarh Movement

(1) The Western Education for Muslims:

The most important purpose of Aligarh movement was to educate Muslims.

This education was the attainment of the western education. Muslims were lagging ^{far} behind from Hindus. The bonhomie of Hindu with Britishers was ~~far~~ further pushing the Muslims back. Thus, Sir Sayyad committed to uplift Muslims and to save them from elimination as a nation in subcontinent.

(2) Economic prosperity:

Education was directly responsible for economic prosperity. As the Muslims were uneducated, they were not given jobs in government sectors. Hindus were dominant in every sphere, and were economically prosper. ~~Muslims~~ Muslims were further downfalling. The poverty level was

increasing among Muslims. Thus Aligarh's aim was to educate Muslims so that they could get jobs and gain economic prosperity.

3. Social status:

A poor has no social status. The Muslims being poor and economically weak had no status in subcontinent that time. English were favouring the Hindus. As the Hindus had happily accepted the Britishers and their education and culture. Thus for raising social status, Muslims had to gain economic progress and economic progress could not be achieved unless education.

Modus Operandi of Aligarh Movement

- (i) Attaining the Western education the panacea for all problems of the Muslims

Aligarh movement's aim and way of uplifting Muslims was only education. Being an educational movement, Aligarh movement had taken the following steps for education:

A. Translation of key English books and magazines into Urdu

Sir Sayyad translated key books and magazines in Urdu so that poor and common Muslim masses get awareness. He tried to give assurances to both Muslims and Britishers that two enemies can be friends, so forget what had happen and move forward for cooperation with each other.

B. Established school at Murad Abad:

The first educational institution Aligarh established was school at Murad Abad and Ghazi pur. It was the practical step to educate Muslims. In these schools both eastern and the western education was

given to the students

c. M-A-O college ::

Sir Sayyad also established Muhammeden Anglo Oriental College (MAO college). It was a best institution. Basically, Sir Sayyad was impressed from ~~exam~~ Cambridge and Oxford University. He ~~was~~ wanted to make it a university, however, it could not materialized unless his death. Later, it named as Aligarh Muslim University.

d. Aligarh Scientific Society ::

Through Aligarh movement, Sir Sayyad also established a scientific society. Its aim was to translate English magazines, books etc into ~~English~~ Urdu while ~~urdu~~ into English. Beside this it tried to make culture and civilization understanding among Muslims and Britishers.

e. Muhammeden Educational Conference ::

This conference played a

crucial role in uplifting the Muslims in subcontinent. This gave awareness to the Muslims that Hindus are subjugating Muslims with help of Britishers. Without getting education, Muslims cannot progress. Thus ~~Muslim~~ Muhammadan educational Conference played a vital role in this regard.

ii. Progress in Economics:-

According to Sir Sayyad Muslims cannot survive politically and socially, if they could not make progress and become economically strong. Thus, through education economic progress is possible.

(iii) Principle of Trinity of Sir Sayyad:-

According to principle of trinity of Sir Sayyad, Muslims have to follow three things in order to survive as a nation in the subcontinent.

a. Aloofness from politics:

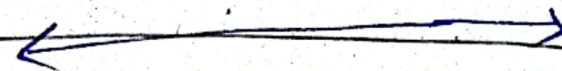
