## 2. IMPORTANCE OF ZAKAT: AND ITS PHILOSOPHY

### i. Purification of Wealth:

Allah commands His followers to give "Zakat" so that the remaining wealth be purified. Allah says in

Quran:

فَاذْكُرُوا نِعْمَةَ اللَّهِ عَلَيْكُمْ إِذْ كُنْتُمْ رِجَالًا وَكُنْتُمْ فِي الْبِلَادِ الْيَتَامَىٰ وَالسَّائِلِينَ وَقَدْ خَلَقْنَاكُمْ وَإِلَيْهِ الْمَصِيرُ "La"

"Take ~~alms~~ from their wealth so that the remaining money is made pure and clean."

### ii. Circulation of Wealth:

Zakat is made obliged for the rich to give to the needy and impoverished community. This will create circulation of wealth among different groups and improve financial conditions of the poor. Allah has made different groups and provided different opportunities to testify their rationality and obedience. Similarly, Economic superiority of certain groups is a test for them to circulate wealth through the ordinance of "Zakat."

iii Controlled Economy:

Allah has given basic instructions in Quran to have distinct economic system for an Islamic State. Allah ordered Muslims to Zakat to internally manage the economy of the state. Zakat will provide equal economic opportunities for every muslim. ~~despite of his race, colour or caste.~~

iv Support of Marginalized Community:

"Zakat" is made obligated for every muslim to give once a year. If he has almost 7.5 tolas of gold or comparative merchandise. This Zakat is given to eight subgroups mentioned in Quran:

"Allah is only for the needy and the poor, and the caretaker of Zakat, and for those whose hearts are inclined to the truth, [for ransoming] of captives, for repayment of Debt, in the way of Allah and the wayfarer, an ordinance of Allah and Allah is knowing and wise."

(Al: Quran)

## v. Obligatory Worship:

The importance of Zakat can be illustrated by the ordinance given by Allah as an obligation for eligible muslim. Allah repeatedly command muslims to give Alms in Quran:

اقوموا واركعوا مع الراكعين

"واقوموا الصلاة وادوا الزكاة واركعوا مع الراكعين"

"And make up to your prayers and give your Alms and prostrate with those who prostates."

(Al: Quran)

## 3. SPIRITUAL BENEFITS:

### vi. Closeness with God.

The obligation of Zakat brings spirituality among muslims. Their belief within their God strengthen and see this world as temporary stage. They shatter the rings of fake world and observe the spiritual world without any external interference.

## ii, Abstinence from Worldly Pleasures:

Providing Zakat to the needy from ones own income and belongings keep muslims to avoid excessive worldly desires. They do try to keep a balance within their finances and live a simple and peaceful life. However, it should be noted that Islam never supports asceticism, as illustrated by the advice of Holy Prophet (S.A.W) to Hazrat Abu Bakar at the Battle of Badr. He emphasized the right of "Nafs" and family over our belongings and existence.

## 4. MORAL BENEFITS:

### ii. Empathy:

Zakat teaches muslims to be empathetic towards their muslim brothers. This brings humility among muslims towards the poor and impoverished community.

## ii, Humanitarian Assistance:

The eligible candidates for receiving Zakat do not <sup>only</sup> include the poor community, but various categories and divergent groups of eligible people demonstrate that Islam focuses every social group. Zakat will assist humanitarian issues such as debt, slavery, poverty and institutional finances.


## 5. SOCIAL BENEFITS:


## ii) Reduce Class Distinction:

” يَا أَيُّهَا الَّذِينَ آمَنُوا اتَّقُوا اللَّهَ وَذَرُوا مَا بَقِيَ  
مِن الرِّبَا إِن كُنْتُمْ مُؤْمِنِينَ .”

“O you who have believed, fear Allah and give up what remains (to you) of Interest, if you are believers”

(Al-Quran)

## ii. Taking Zakat from Muslims:

Zakat is fundamental part of Islamic economic system. It is an obligation for Islamic state to take Zakat from eligible people.

However, it should be not that personal belongings of any individuals included two categories i.e.

- Maal-e-Batani (Internal Belongings)
- Maal-e-Zahiri (External Belongings)

Islamic state is made obligatory to take Zakat on External belongings, which are clearly visible and can also force muslims to give alms. This is demonstrated by Jihad against of Hazrat Abu Bakar (R.A) against the deniers of Zakat during his reign.

### (iii) Leveraging Economic Gaps:

It is responsibility of Islamic state to leverage economic gaps among different groups of society. Many societies have wide class distinction resulting in social chaos and jeopardy. Therefore, Islamic state should provide feasible economic opportunities for less privileged people in the country.

## ISLAMIC PRINCIPLES TO ADDRESS CONTEMPORARY ECONOMIC ISSUES:

### i) ~~Balanced Consumption:~~

Islamic principles promote balance between income and expenditure. This moderation will create harmony of finances and economy in today's world. Nowadays, everyone seeks unattainable goals influenced by their peers. Thus, a balance means of consumption can counter this challenge. ~~Hally~~ Prophet (S.A.W) said:

"Moderation between Income and Expenditure is half the pleasure of 'Economic life' (Hadees).

Allah says in Quran:

## ii, Circulation of Wealth:

The basic principle of Islam related to circulation of wealth through Zakat address the deep polarity within society.

Islam implies circulation of wealth from the rich group to the less privileged group. According to recent ~~recent~~ states almost 49% of world economy lies in the hold of 1-1% of wealthy people. Considering this fact, circulation of almost half of wealth can create economic balance in society.

# WOMENS RIGHTS IN ISLAM:

## i. SPIRITUAL LEVEL:

Islam does not distinguish humans based on gender or race, instead it categorize humans on highest spiritual level. Both men and women have equal access to attain spiritual superiority. Allah says:

"The closest to Allah among you (male or female) is one who is at utmost spiritual level"

## ii. EDUCATIONAL LEVEL:

Islam doesnot prevent women from attaining education. Holy Prophet (S.A.W) himself used to allocate time for teaching women. Holy Prophet (S.A.W) said.

"*طُوبَى لِمَنْ سَأَلَ عِلْمًا فَهُوَ لَهْ*"

"Seeking knowledge is mandatory for every muslim (male or female)"

### iii. LEGAL LEVEL

#### a. Witness:

Previously, women were not given opportunity to witness in criminal or civil cases. However, Islam gave opportunity to witness in legal proceedings.

#### b. Punishment to False Accusers:

Islam maintains respect for women by restricting doct of false accusations against the women. Allah says in Quran:

"Whoever, falsely accuse the chastity and morality of women punish without giving four witness, punish him with Eighty (80) lashes"

(Al: Quran)

### iv. ECONOMIC LEVEL:

#### a. Ownership:

Islam provide opportunity for womens to own or disown any economic property. However, western countries did not maintain ownership rights for muslims until late 1870s when special married women ownership bill was passed.

## (b) Employment:

Islam assists women to have employment under certain conditions within Islamic boundaries. Over Islamic history, many muslim women pursued business such as Hazrat Khadija (R.A), medicine and law.

Islam provide great opportunity for women to have economic independence.

## (c) Inheritance:

Allah commands followers to give half the portion of male inheritance. As the economic responsibility relies above male, she is provided with additional financial assistance through inheritance.

## (d) Financial Burden:

Women are devoid of any financial burden in Islam. Before marriage it is responsibility of her father and brother to provide her. After marriage, it is utmost responsibility of her husband to give living necessities.

## e. Marriage Gifts:

It is made obligatory on Muslim males to give marriage gift "Mahar", otherwise Nikkah or legal bond cannot be commenced. Furthermore, it is also responsibility of Muslim males to give financial assistance if women get "Khullah" or Divorce. And if she get pregnant, he is obliged to fund till the delivery.

## iv. SOCIAL LEVEL

### a. Marriage:

Islam orders its followers to take consent from women in marriage. No one could force her to marry someone without her wish.

It can be illustrated by incidence during life of Holy Prophet (S.A.W) when a girl approached him and said she was forcefully married. Holy Prophet (S.A.W) gave authority to the girl either to continue or dissolve marriage according to her own will.

## (b) Partners of Males:



### (a) legislature:


