According to the Criminal Procedure Code 1898 of Pakistan that section 309, that a juvenile delinquent is one whose age is 17 years. Pakistan Penal Code the age is 16.

3) Definition of Juvenile delinquent

4) The Juvenile Justice System of Pakistan

In the history of Pakistan various ordinances and acts passed by the legislature to update the juvenile justice system in the country.

i) Sindh Act, 2019

In the Sindh the juvenile were treated under the Bombay Act 1855. The Sindh government replaced it with the Sindh act in 2019.

According to this Act, The court cannot sentence ~~a ju~~ to death a juvenile. Moreover, he/she cannot

trial in a joint court.

ii) Juvenile Justice System Ordinance 2000:

During Pervez Musharraf presidency he passed a JJSO, 2000, in which he implemented some fundamental rights and trial procedure of the juvenile. According to this act a separate court were established, their age were fixed to 18 years, joint trial were forbidden. Moreover, the state was responsible to provide a prosecutor to juvenile having at least 5 years experience.

iii) Punjab Juvenile Act, 1983

Punjab has also implemented their own act in this province. Who has also provided some fundamental rights to the juvenile under the law. Moreover, conditions of the act was similar that like of the JJSO, 2000.

iv) The Hoodood ordinance 1979

During Zia ul haq a Martial law he implemented Shemia into the

country. According to the Sharia law a juvenile should remain juvenile after the reaching at the age of puberty. Zia ensured that a child who commits ~~them~~, ~~he/she~~ did not remain a child and must be lashed upto 30.

5) Criticism on the JJS of Pakistan

- i) The JJSO, 2000 were not extended to FATA and PATA region of the country at that time.
- ii) Zia has reduced the age of Cr.P.C 1898 section 399 from 18 to 14.
- iii) The Punjab Youth Ordinance 1983 and Sindh Bombay replaced. ~~ordi~~ act was limited only to their respective provinces.

i) To form a separate Juvenile Justice system and their courts.
