Aligarh Movement played a significant role in creation of a sense of political consciousness among Muslims. Prior to Aligarh movement, Muslims of the subcontinent were illiterate and devoid of political consciousness. To them, they were ^{repressed} subjugated by the British India in exciting war of independence 1857. British India held Muslims responsible for the havoc ^{which was} created in during 1857. Sir Syed Ahmed Khan, the true pioneer of Aligarh movement, made it clear that Muslims of India are innocent and have no prejudice towards British. Besides, the Aligarh movement created a link between the Muslim towards education in order to protect their true identity. With education, it really played a clarifying role in helping Muslims to take part in politics to know their ^{presence} basic rights in the subcontinent. Thus, Aligarh movement injected a new life into the dead body of the Muslim nation and helped to regain its lost glory and prestige.

Background of Aligarh movement

The Muslims of India no doubt faced a lot of challenges after the war of independence 1857. They were held responsible for the mutiny and they were enforced in such a way that they never rise to the glory. The British suppressed them politically, socially, religiously and in economic level. All the prestigious ranks were handed to the Hindus and lower ranks to the Muslims so that they keep on subsiding by Indians. As Nehru opined that "the heavy hand of British fell more heavily upon Muslims than Hindus."

In order to ease the pathetic condition of Muslims, the renowned personality / scholar, Sir Syed Ahmed Khan laid the foundation of Aligarh movement. It played a significant role to uplift the Muslims politically, socially as well as on educational level. Indeed, it regained their pride.

3- Educational Motives

1- Development of sense of modern education
 During the time of independence, the Muslims were strongly illiterate and particularly devoid of modern education. By the help of Aligarh movement, Muslims were ^{taught} given modern education so that they could remove the British agitation. Despite of learning Urdu, Muslims were forced to learn English language to preserve good position in the India.

ii) Foundation of educational institutions

Before prior to Aligarh movement the Muslims lacked any proper institution where they could get education properly. They had ~~facilities~~ facilities of Madrasa education only which was not modernized. ~~In~~ through the Aligarh movement, a number of educational institutions were established. Such as, Madrasah Muradabad, Ghazipur Madrasah, MAO Aligarh School, MAO College and Mohammadia Educational Conference. 1826.

Establishment of Mohammedan Educational Conference
 The Sir Syed Ahmad Khan established the conference to extend the scope of Aligarh Aligarh institutions. He believed that only education could not be sufficient for the need of Muslims. The conference proved to be a national platform for the Muslims.

Establishment of Scientific Society.

With the help of Aligarh movement a scientific society was created for the Muslims. In which more than 800 books and other ~~hundreds~~ ^{hundreds} of different subjects were translated into Urdu.

Amalgamation of group of scholars

By the Aligarh movement, a group of ^{Muslim} intellectuals emerged who helped Muslims in providing education to them. For instance, Mahsun-ul-Mulk, Haqar-ul-Mulk, Shibli Nomani and Mulla Zakaullah who were educated in Aligarh colleges.

2- Background of Pakistan's Economy

Since inception of the country, Pakistan is weaker economically. Firstly, India did not ~~give~~ return out of 7 million rupees ^{after} dividing into two independent states. Secondly, there was lack of efficient economic policy to stabilize economy smoothly. Besides, Pakistan dependence over aid since 1956 when it became the US ally. After 1971 war, Pakistan's economy become smooth ~~in~~ during military rule but completely melted down during civilian government. Since ~~inception~~ ^{inception}, Pakistan is taking aids and it has taken 23 times loan from IMF. Though multiple times the ~~same~~ successive governments got opportunity to stabilize its economy, due to internal divisions and high expenditures, the ruling government could not stabilize economy.
