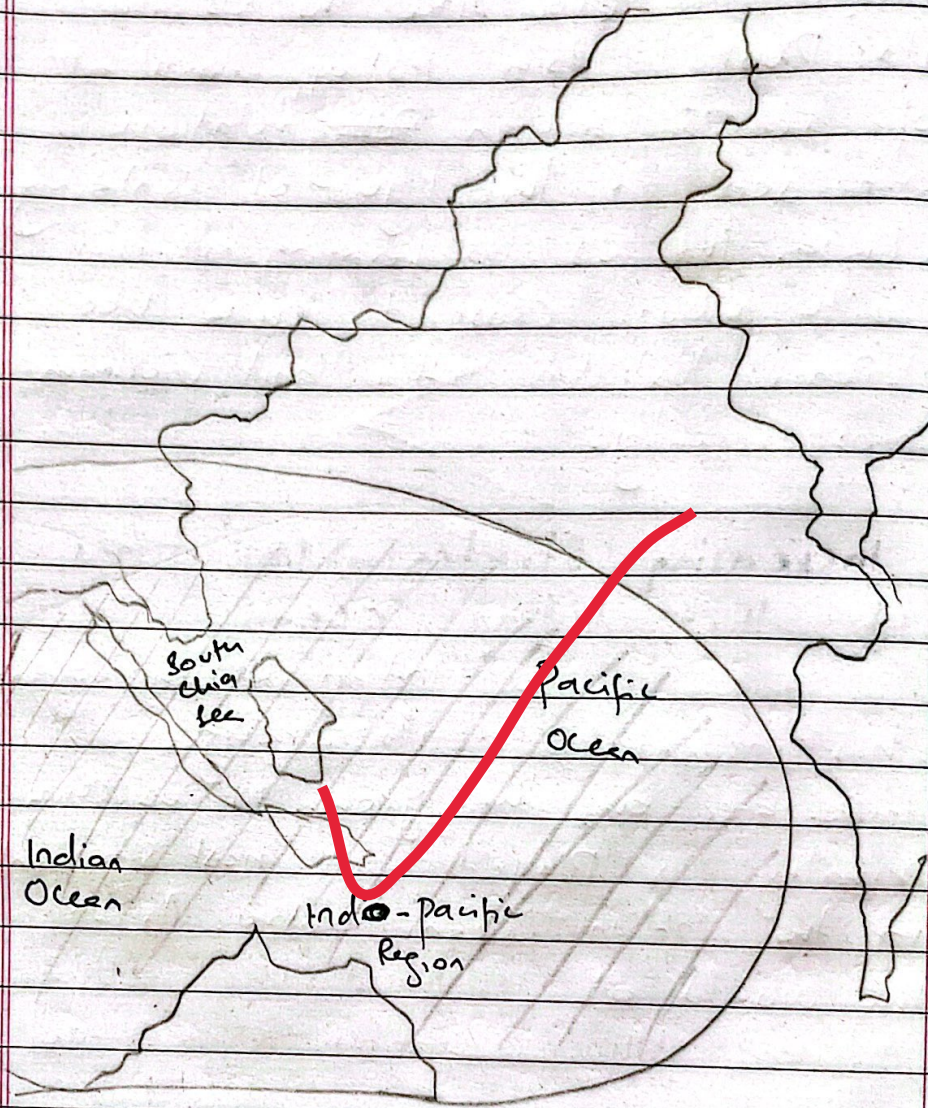

Status of United States peaked between the fall of the Berlin wall (1989) and the global financial crisis of 2007-2009. The world has been reverting to a more normal state of multipolarity ever since with China, Russia, India, Europe and other powers centers gaining power relative to the United States. The most significant threat to the hegemony of US is posed by China's growing economic, technological and strategic importance. Both China and US are working for gaining global power. This US-China rivalry is played out most aggressively in the Indo-Pacific region in general and in South and East China Seas in particular. The issue of Taiwan is an important flashpoint in US-China rivalry. Semiconductors are the lifeblood of modern technology. China and the US are in a race to gain superiority over the other in terms of semiconductors.

### The Taiwan Crisis: historical overview

As a result of this provocation, China launched multiple military drills around Taiwan for two days. This visit soured the already strained relations of China and US with each other.

## The US-Japan-South Korea alliance

The US President Joe Biden announced an alliance of US, Japan and South Korea in 2 September, 2023. This alliance again proved China to launch military drills and even missiles over Taiwan. China accused US of adopting a cold war mentality towards China while the US President stated that the alliance was not meant for containing China. The South China Sea and the Island of Taiwan are two major flashpoints for US-China rivalry.

## Diffusing tensions between China and the US

Tensions between China and

The China Pakistan Economic Corridor (CPEC) was launched by the Chinese President Xi Jinping in ~~2012~~ 2013. The CPEC is widely believed to be the flagship project of the wider Belt and Road Initiative (BRI). Ever since its launching, the west has had apprehensions over the ambitions of China whereas inside Pakistan, it is believed to be 'gamechanger' for Pakistan. The CPEC has now entered its second phase which is more broader in its objectives and targets than the Phase I. A decade ~~is~~ has passed since the launch of ~~CPEC~~ CPEC but Pakistan is yet

to reap full benefits of the project.

## Completion of the Phase I of CPEC

The CPEC project was initially announced to facilitate the investment of 62 billion dollars by the Chinese in Pakistan. Pakistan has so far received 25.4 billion dollars in direct Chinese investments in addition to the huge loans and currency swap agreements. The first phase of CPEC focused primarily on roads and infrastructure, ~~establishing~~ building the Gwadar Port and power generation. CPEC has now entered into its second phase which is much broader in scope.

## Achievements of CPEC so far

The first decade of CPEC was dedicated to infrastructure but building and employment generation ~~to~~ through those projects.

## Building roads and infrastructure

Under the CPEC, a number of highways and motorways have been ~~built~~ built connecting the Gwadar and Karachi sea ports to China. Along with roads, infrastructure in exclusive economic and special economic zones has also been constructed which

## Gawadar City and Gawadar Port

One of the major focus areas of the first phase of CPEC was the building of the Gawadar Sea Port and the erecting of the Gawadar City. Billions of dollars have been invested in Gawadar under the CPEC.

## Employment generation

The infrastructure projects of CPEC generated thousands of jobs especially for the daily wagers. Local people, through the CPEC project, found an opportunity to earn their living. Moreover, for maintenance of the development projects, local professions would be employed for example the Toll Plaza's on the motorways.

## Key failures of the CPEC Project

Pakistan is yet to utilize CPEC as a potential game changer. Before Pakistan could emerge on the world stage as an important transit spot between Asia & South Asia and the middle east, some key challenges need to be overcome.

## Insufficient local job creation

Despite the fact that the CPEC project was supposed to create jobs which would lead locals out of poverty, there has not been sufficient job creation under it. The Chinese producers are believed to prefer its own workforce over Pakistani locals when it comes to technical jobs. A major chunk of employment under the CPEC in Pakistan is only in labour work by daily wages. This has been a major failure of the CPEC project.

## Local residents of Gwadar are Sidelined

The Chinese built Gwadar city and Gwadar Sea Port are completely fenced, severing ties with the local residents. Local residents are hardly consulted on matters important to them. Locals are denied access to important fishing spots in the Gwadar sea which has resulted in resentment for CPEC among the locals.

## Chinese Direct Investment

Pakistan has not received any substantial amount in foreign direct investment by the Chinese under the auspices of CPEC. Pakistan needs Chinese investment in

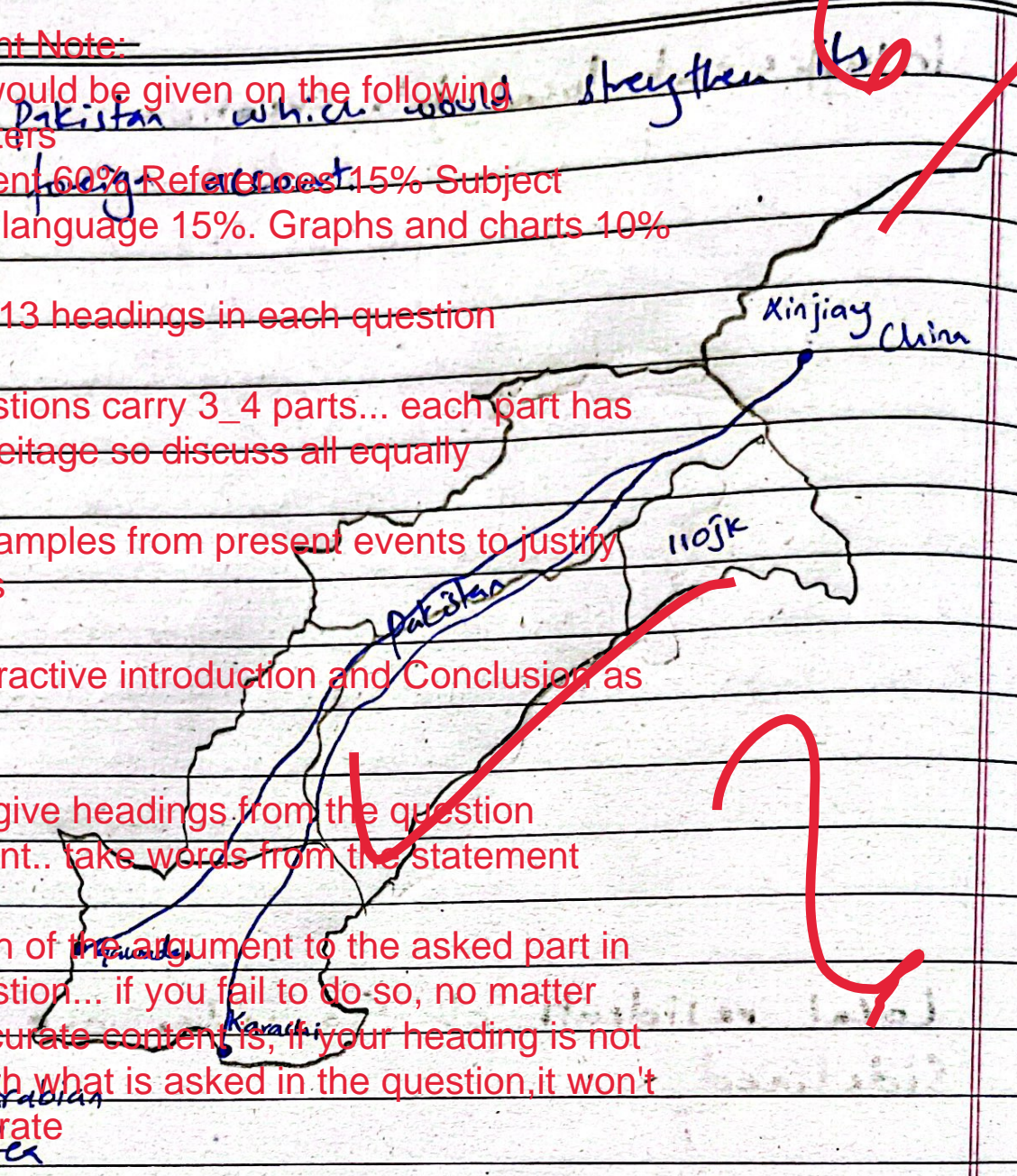
