

Similarly, the downfall of Enron Corporation in the early 2000s provides a modern example driven by the pursuit of financial greatness, engaged in unethical practices and financial manipulation, neglecting the responsibility to shareholders, employees and the public. This disregard for ethical responsibility resulted in one of the largest corporate bankruptcies in history, leading to the company's bankruptcy and widespread damage to its stakeholders.

Another major factor Leadership inherently involves a significant burden of responsibility, as evidenced by various historical and contemporary figures. Effective leaders must balance personal ambition with the ethical demands of their role, influencing both their legacy and the well-being of those they lead. According to 2022 Study by the Center for Creative Leadership, 85% of successful leaders attributes their effectiveness to their ability to manage and embrace their responsibilities, including ethical decision-making and accountability. For instance, Nelson Mandela's leadership in dismantling apartheid in South Africa was marked by his great sense of responsibility toward justice and reconciliation.

As Martin Gilbert explores in "The Price of Greatness", Churchill's tenure as Prime Minister exemplified how embracing responsibility is crucial for political success. 
