### Introduction.

- Bangladesh being an independent and South-Asian country, stays on important position in the world. The country got its independence in 1971 following the rule of Mujeeb-ur-Rehman and his daughter Ms. Sheikh Hasina. Bangladesh stayed in this autocratic regime of Sheikh Hasina till Aug 2024. However, her long rule brought turmoil in the country resulting in decline of her rule.

### Historical perspective

Following this situation, the students led protests demanding their structural rights from the government



In response to which the government refused to accept the demands of students



In a result of this, the protests turned into violent protests resulting in deaths of civilians.



Because of this much immense pressure from the students, the government was unable to give a counter-narrative and Sheikh Hasina fled the country, withdrawing from her long lasting position.

## Analyzing the political Earthquake in Bangladesh

- Bangladesh has gone into serious political crises following the recent turmoil and decline of Sheikh Hasina's regime.
- The situation resulted in deaths of civilians as well as government persons. The pressure of protests did lead to the end of Hasina's government. But, she has put the state in emergency.
- The country has gone into serious political crises because of lack of above authority and have created a situation of Anarchy.
- However, the state needs to take an urgent action towards the fair and free elections so that the state will come back to its position gradually.

## Possible fallouts of the situation

The recent situation can lead towards different other impacts like:

1. Political instability could give rise to Economic disturbance.
2. The recent situation might engage the Non-state and rebellious actors causing more destruction.
3. The students can put up more demands as they have known the power of their pressure.

## Currency War

- An important aspect of rising tensions between US and China is their increasing currency war.
- Currency remains as an important aspect in dominating the world and being an authoritative figure among the countries. US uses the currency tactic long ago to maintain its hegemony over states following its Great Bretton woods system.
- US conducts its trade with other nations in its own currency, Dollar. As who control the world finances, will control the world! and Dollar remains the top most currency around the Global.
- However, China, in recent times has come up and is giving an Anti-Thesis to the US Dollarization to De-Dollarization.

- China has come up with the tactic of Currency Swap agreements and is conducting trade with the other powers in either his or their currencies.
- However, this very initiative of currency swap agreements is giving dents to the US hegemony.
- Also, China is using the 'BRICS platform' to conduct the currency swap agreements and process of De-dollarization. As, BRICS countries contribute around 24% GDP of world which will eventually have far reaching impacts over the International political Economy and resultantly, on US's Economy.
- Both the countries are in continuous cycle of power where US wants the 'continuation' of dollarization and China wants to de-dollarize it.

## Introduction.

- Two state solution is the best solution in times of conflict and results in peaceful resolution.

- Currently, this 2nd option is also not suitable for Israel.  
As "Israel is going towards Greater Israel" (As per Noam Chomsky) and in the two state solution states have to compromise on territorial authority. Israel, right now doesn't seem to give on territorial authority and intends to capture and dominate more land, so this situation is also not possible in the current scenario.

### 3. Apartheid state

- Third option for Israel is to put Palestine in a state of Apartheid where they are segregated from them, considering Palestinians as 2nd class citizens and by not giving them equal opportunities as they do have.
- Israel has opt for this option and currently has gone too far. Palestinians are in a state of apartheid where they are treated as 2nd class citizens, don't have even the basic rights, can't have the nationality, property

and are in a state of dying from shortage of food, water, electricity, home, etc.

- Israel opted this option for long years and now have turned into a more lethal form. Israel has even violated the international law by conducting the worst crimes against palestinians.

#### 4- Ethni cleansing

- Ethni cleansing is the worst form of killings. by clearing an area, removing or killing of a certain group to become Homogeneous.

- Israel has opted for this solution in such a way that is conducting a great number of killings on daily basis.

- Ethni cleansing in palestine by Israel has become one of the most brutal form of Ethni killings in history. and Israel intends to kill all the palestinians in a row.
