Pros of Two Party system:

- i) It prohibits the extremism, when there is a multi-party system

is place, then anyone with a view that is exceptionally conservative or liberal can become a representative in the government.

ii) Every person is eligible to run the office.

The primary system in the U.S acts like what a multi-party election does for other governments with one key exception: instead of sending representatives into office, it creates a run-off election to choose one person. This process allow to choose one person to represent them on behalf of party.

iii It speeds up the governance in state.

The two-party system makes easy for the government to react quickly to the situation. There is a systematic way of procedure which decentralized till local governments.

Introduction:-

The role of Sir Syed Ahmed Khan, Allama Iqbal and Quaid-i-Azam have played an important part for the rise of Muslim nationalism in South Asia. This sense developed among the Muslims before the establishment of Pakistan. Their goals was mostly to protect and promote their identity and interests and shape their lives in accordance with their beliefs and philosophy of life. The role of leadership is very crucial to put nations on the way. A good leader has the qualities of awareness, consciousness, mobilization, sense of direction and defence against the adversaries. The Muslims were lucky having such competent leadership.

Role of Jinnah

Jinnah played a dynamic role in the articulation of Muslim demands

and pursuing these faced strong opposition from the Hindus and the British.

Jinnah used the term Nation for the Muslims of India in February 1935 (in Legislative Assembly). He argued that the combination of religion, culture, race, arts, music and so forth makes minority a Separate Entity.

Two nation theory & Jinnah.

He said the Muslims are a nation by every definition of the word nation. They have every right to establish their separate homeland. They can adopt any means to promote and protect their economic, social, political, cultural interests.

Allama Iqbal

Allama Iqbal a great political leader and a reliable companion of the Quaid-e-Azam. He awakened the Muslim from his verses and demanded separate

home land.

Separate identity of Muslim by Iqbal.

Allama Iqbal believed in the separate identity of the Muslims as a 'nation'. He said that, 'I am fully convinced that Muslims of India will ultimately have to establish a separate homeland as they cannot live with Hindus'.

Muslim nationalism by Iqbal.

In the Presidential address dated 29/12/1930 Iqbal said that, 'I would like to see the Punjab, NWFP, Sind & Balochistan merged into a single state or states'. The famous Pakistan resolution, passed on 23rd March 1940 at Lahore was in fact the result of Allama Iqbal's presidential address of Allahabad.

Iqbal & Jinnah

Iqbal & Jinnah was personal associated with each other. It was Iqbal that influenced Jinnah in convincing Jinnah to end his-self-imposed exile in London, return to India and take charge of the Muslim League.

Sir Syed in Politics!

In the politics, Sir Syed play an important role of Muslims of sub-continent. He ended the misunderstandings between the Muslims and the Britishers.

Sir Syed & Two nation theory

Sir Syed supported the two nation theory. The incident of Urdu Hindi controversy in 1867 in Banaras, changed his views then he gave the concepts of two-nation theory (Muslim Separatism) and ideology of Pakistan (Muslim Nationalism).

Introduction:

The Judiciary, executive and legislative actually to be separated by term of separation of powers and if this not happen then 'the tyranny' will take place. These multiple branches of government help to ensure that no one branch is more powerful than another. — ?

This can be explained by Montesquieu's theory:

It states that, liberty of the individual required that neither all these powers nor any two of them should be placed in the hands of one man or one body of men.

1) Legislature and executive powers are united:-

When the legislature and executive powers are united in the same person or body of person, there can be no

liberty; because the king, who is also the law maker, might make and enforce the law in a 'Tyrannical Manner!'

b) Judicial power joined with legislature:

If the judicial power joined with the legislative, 'the life and liberty of the subject would be exposed to arbitrary control'.

c) Executive power joined with Judicial

The Judicial power joined with the Executive power, then the 'Judge might behave with violence and oppression'.

d) End of Everything or Tyranny:

If the same man or same body exercise these 'three powers that will create tyranny'.

Separation of power and check and Balances:

The Separation of powers in the U.S.A is associated with the check & balances system. This system provides each branch of government with individual powers to check the other branches & prevent anyone branch from becoming too powerful or create Tyranny.
