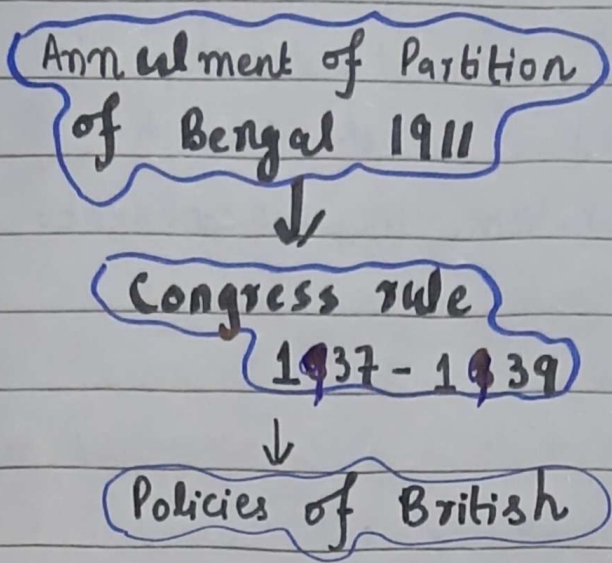

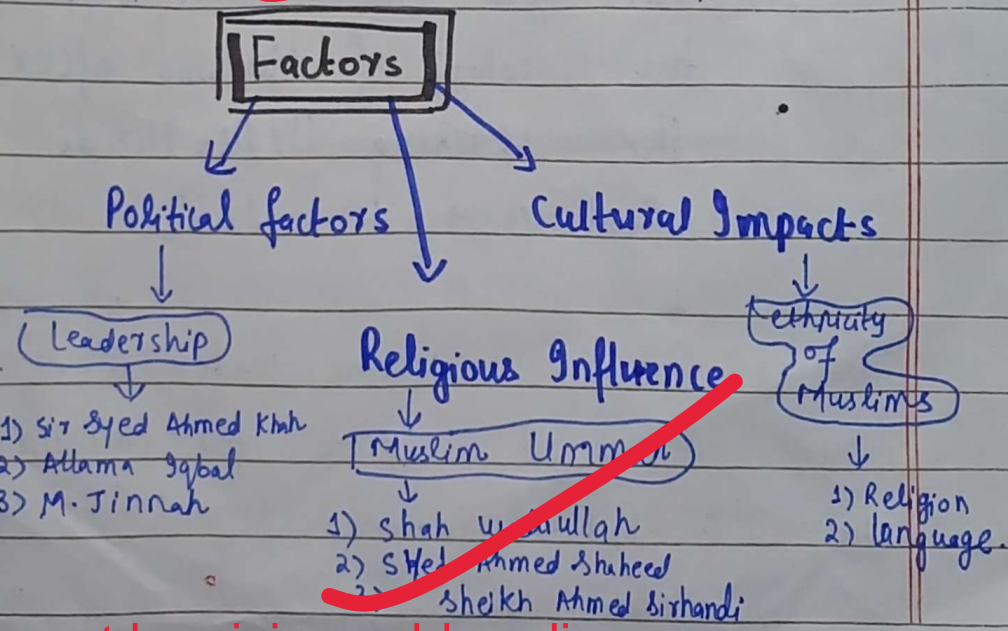

E: Role of Leadership in the Evolution and Growth of Muslim Nationalism in Subcontinent:

Sir Syed Ahmed Khan played a paramount role in the growth of Muslim Nationalism on the basis of lingual issue.

4: Call to All Muslims to Protect Muslim Nationalism:

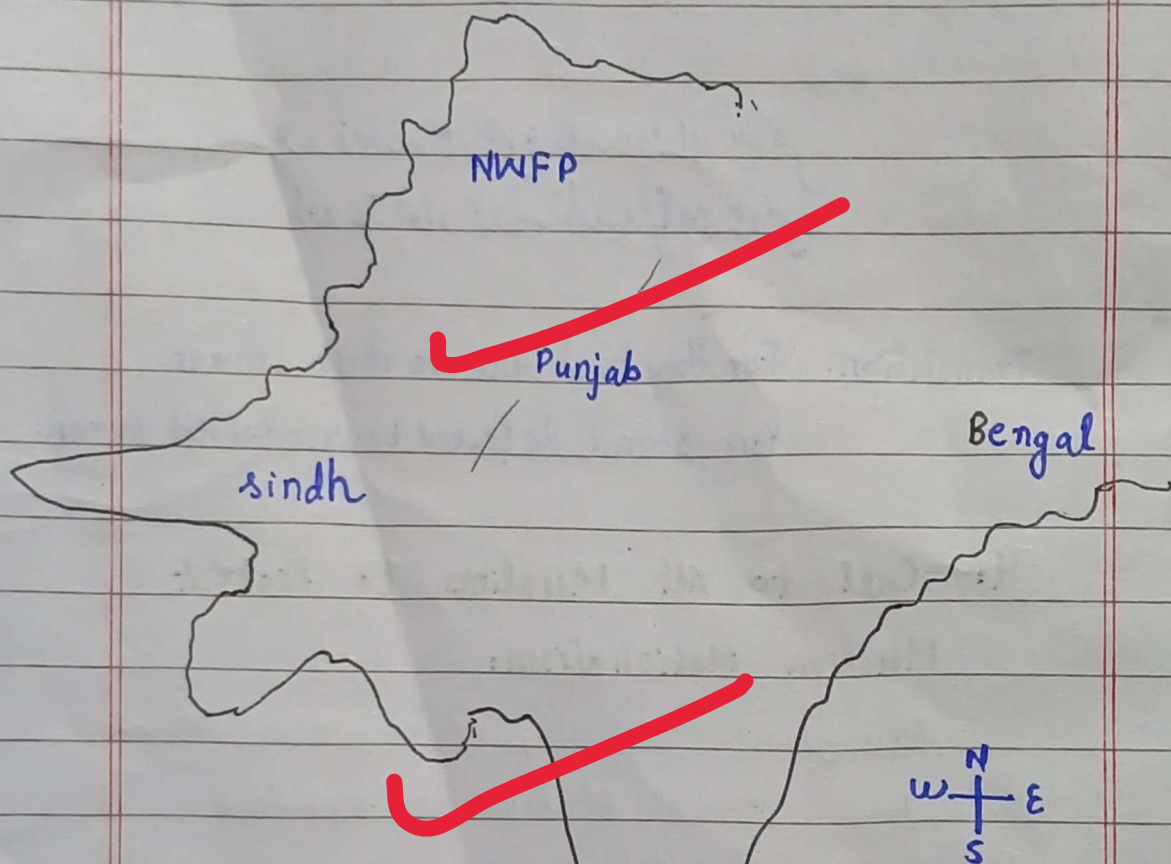
Throughout his poetic pieces, Allama Iqbal has asked Muslims to protect the dignity of Islam and their identity as a separate nation. As he says,

6. Role of Quaid-e-Azam in the Growth of Muslim Nationalism:

Quaid-e-Azam, the greatest leader of the subcontinent, forcefully advocated the plight of Muslims and worked on legislative forums to promote Muslim Nationalism. It was due to consistent political efforts of Quaid that Muslims were able to get a national identity.

Firstly, he was recognized as the Ambassador of Hindu-Muslim unity but soon he realized the separate value and existence of Muslim Nation.

e) Decline in Direct Foreign Investment:

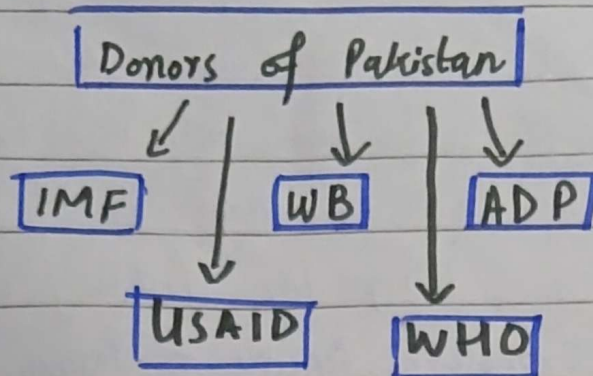

- > TTP's attack on Chinese officials.

f) The economy of Pakistan is Heavily Dependent upon Foreign Donors.

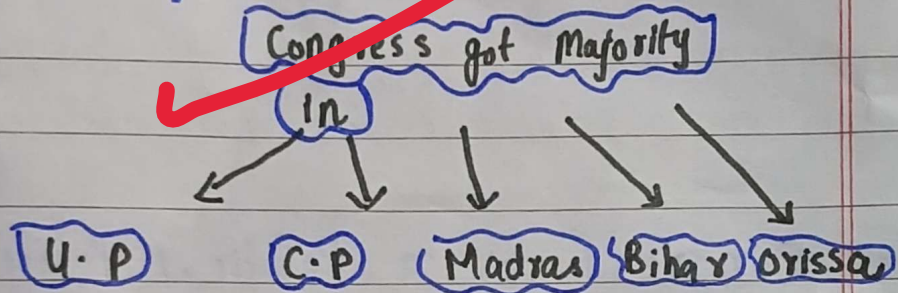
C: Congress Ministries: The Nightmare for Muslims of Subcontinent:

a) Results of the elections:

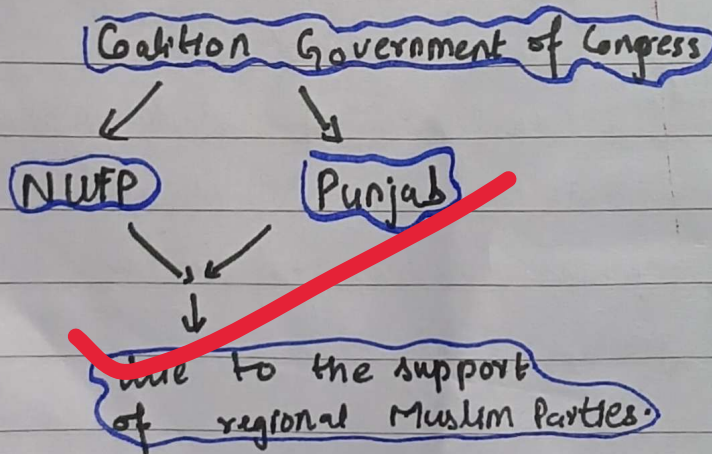
Congress outnumbered Muslim League in five leading provinces. It won 706 seats out of total seats.

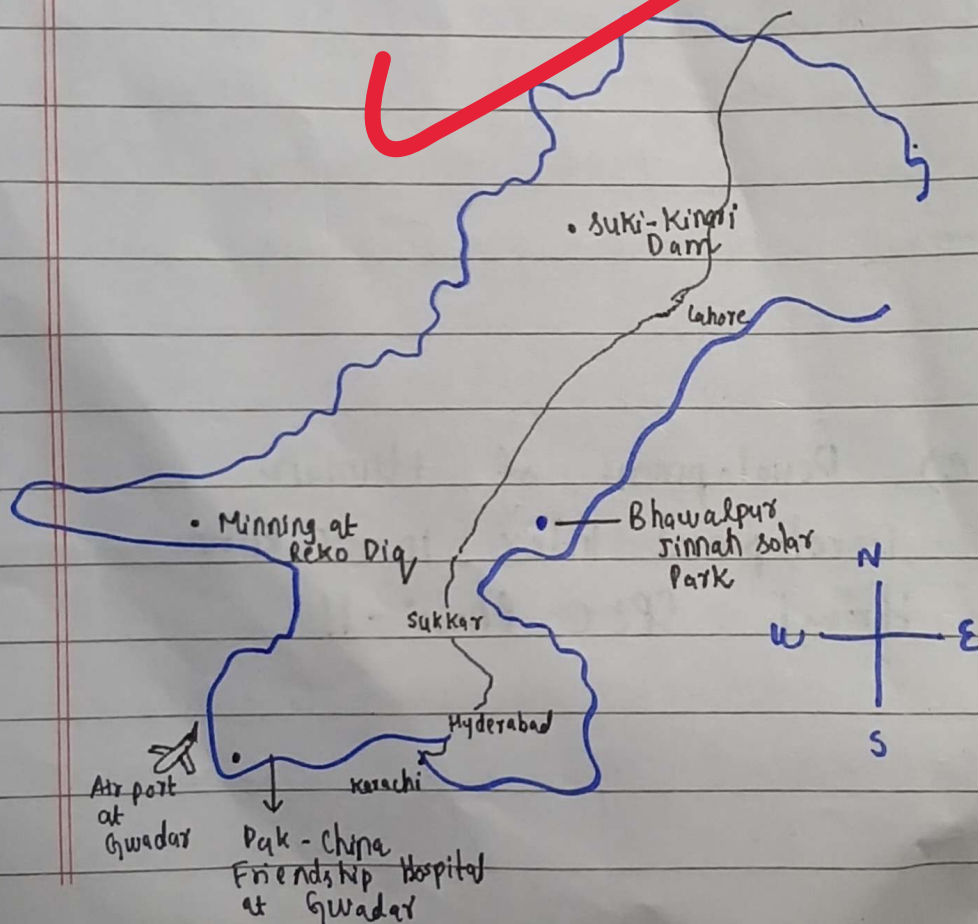
e) Development of Human Development Index in Pakistan through CPEC Phase - II
