Corruption perceptions Index is an Index that ranks states by their perceived levels of public sector corruption. It is not an individual's task rather multiple actors are involved who thoroughly assess the public sector corruption in the states involved. CPI is a tool that exposes such destructive practices. Besides, it paves the road to end impunity for corruption. Scoring 0 on the CPI scale indicates the higher values of corruption on the other hand scoring 100 indicates the country or territory has zero corruption. 2023 CPI report ranked Denmark as the most clean country in terms of corruption. **Pakistan was ranked at 133 out of 180 countries while that of Bangladesh was 149 and 162 of Afghanistan.** CPI present a pathway to eradicate corruption otherwise the menace of corrupt practices would destroy the world as it is the worst disease in the world.

Corruption harms a person as an individual and it renders societies in chaos besides, posing existential threat to the states. Corruption exposes the vulnerabilities of human character. It erodes the sense of responsibility from individual's character. Sense of responsibility is the main deterrent to avoid moral deprivation, but corruption **subverts this directly**, consequently, an
