Thirdly, personal interest of elite rulers involve them in corruption. It is human nature from very beginning of the world to gain power, But, today's

world has become blind in greed of power, wealth, assets that they are involved deeply in corruption. Various examples are present in history when monarchs used to annex and control different states to gain more power and wealth. Similarly, this greed has engulfed the world with corruption. In Pakistan, bribe has now become a cultural norm at every level of almost all institutions from health, education, revenue, to police, courts and parliament.

Firstly, there is a dynamic relation between corruption and unemployment rate in a state. The corrupt government gives jobs by taking bribe from job seekers which result in employment of less qualified individuals.

Secondly, corruption leads to increase in crime rates. Corrupt practices create sense of despondency among individual when there are no jobs and opportunities. People strive hard to earn and support their families. But lack of opportunities leads to poverty, hunger and inability to fulfill basic needs of life, which compells the poor to engage in criminal activities like theft, street crimes, pickpocketing, kidnapping for ransom etc. When a youth involves in these criminal acts, he gets habitual of earning through short-cuts rather than sustainable and respectable earning. These practices have become very common in larger cities of Pakistan like Karachi, Lahore, Faisalabad etc. Same is the case with many developing and under-developed countries of the world.

Thirdly, blending of factors such as unemployment, lack of true leadership, lack of sustainable sources of earning, increased crime rates create skill-less society which can never progress rather with passage of time country faces economic instability and political turmoil and ultimate fiasco of the state. At this time, Bangladesh's Prime minister Sheikh Hasina, is a case in point. Bangladesh is the one of the most corrupt countries.

These protest led Hasina's government into unprecedented situations of political instability in the country, where she fled from her own government after resigning, for sake of her safety of life. Likewise there are multiple examples in the world where corruption is one of the leading factors for reprehensible situation of states.

Fourthly, corruption is a key internal factor for inflation in the world. Corrupt practices related to economy mainly creates a gap in distribution of resources among individuals. Most of the opportunities and resources of the state taken by the oppressive and powerful elites that creates inequality. Corruption deteriorates image of one's country for investment. So, reduction of investors reduces import of dollars also. Reduction of imports hobbles the economy of the state and unequal distribution of resources negatively utilizes the already existing resources of the country, ultimately, prices of commodities rises, hence, inflation.

Fifthly, corruption deprives talented youth from securing their own country. Such as country like Pakistan, is a case in point, in this country there is no appreciation of talent. Talented youngsters are fleeing from country

to get opportunities and they are moving to places where their talent will be appreciated.
