The worst disease in the world today is Corruption. It has claimed more lives than the accidents all around the world. Corruption in its outer sense is considered not much deadly.

But in reality its effects are far more intense than what one can imagine. It effects the morals of the people.

It is rooted in human nature of greed. This greed and the worst disease leads to selling morality. Corruption is the root cause of all the injustice in the world. Corruption is not only of material nature in terms of money but also of influence, protecting the wrong doer and interfering in the normal discourse of procedures.

Protecting someone for getting benefits from him in return it can be of material nature or for power acquisition that will be explained later here how it takes place.

Being muslims corruption is considered haram in our religion and muslims are strictly prohibited to do so any such

act. In Hadith it is mentioned in the following words

"The one who gives bribe and the one who takes bribe the destiny of both is hell." (Hadées)

Even though the Holy Prophet (PBUH) has considered it such an ill and prohibited act but even after that Muslims are more effected by this worst disease although its spread all around the world.

According to Transparency International Report 2023 which is the latest one that published. No Muslim country is in top 10 least corrupt countries of the world according to corruption perception index 2023 of transparency international 2023 report.

Pakistan the only Islamic nuclear power in the world ranks at 133/180 with a score of 29. The top 10 countries include Denmark, Norway, Germany, Luxembourg, Finland and others.

In Pakistan the above rank is justified and seen in practice as every govt. department is effected

by the menace of corruption. This is not done by either people belonging only to lower class but its also done by people belonging to lower, middle and higher classes alike.

Even the cures of this worst disease i.e Anti- Corruption department, National Accountability Bureau and other internal and external accountability and corruption controlling departments are itself effected by corruption. Not everyone is corrupt but corruption is found everywhere and in every walk of life.

There are incidents where Anti-corruption and NAB officials have committed corruption not just of material nature but like keeping a person in their lockups without any solid evidence and due to political agendas and working on the directions of the present govt. Its not a recent example its happening over decades that they are being used for political engineering of the political parties.

Similarly, the judges are also compromised, either due to influence, pressure or threats or material greed.

Above we can see the cures of this worst disease of corruption are also effected by corruption now we see the Doctors who treat all the diseases of patients but unfortunately they are also effected by a disease and that disease is the worst disease in the world and that is corruption.

Doctors and pharmaceutical companies nexus involved in looting patients and depriving them of their hard-earned money is also a corruption.

Doctors due to their commissions and other incentives only recommend expensive multi-national companies drugs. This argument can be bought here that patients demand MNCs drugs/ medicines but not everyone does so, as majority of the population in Pakistan and globally is poor and middle class so their argument can be valid for 5-10% of the patients or

for highend localities. But why even the poor who cannot afford the medicine even cheap or expensive are also given the same medicine irrespective of the fact that they can't buy them. Such patients are forced towards taking loans as doctors have not provided them with an option to purchase the same formula. In market drugs with same formula are sold at 10 times of the prices but doctors do not recommend the formula but recommend medicine of a specific brand which is the worst form of this disease i.e corruption. Doctors do this for their commissions in the medicines and trips abroad are also sponsored by pharmaceutical companies and gifts are also given to doctors and even cash is given at some instances. Their personal expenses are borne by pharmaceutical companies. This is the corruption as you are not performing your duties according to your oath which you take as a doctor when you wear the white coat.

All this corruption money is considered as marketing expense by pharmaceutical companies. and the biggest of all expenses even more than 50% of marketing expense even seen at 85% of the companies total expenses. This is the reason drug regulatory authority allows only 5% as marketing expense.

Similarly, this marketing expense is also allowed to the tune of maximum 10%.

according to Income Tax Ordinance

2001. Any expense in marketing head above 40% is **disallowed** i.e. they cannot claim any tax benefits.

Doctors and Accounts offices of Govt are also operating a nexus where all of the medical related funds are withdrawn by doctors and Accounts offices staff by fake receipts and bills just after the budget which leads to no money left for

genuine government servants to claim their medical expenses and bills. Such acts can at times claim lives of people who are suffering financially and are

unable to afford the medical expenses. Their greed of few bucks has lead to someone else loosing their Lives.

This corruption is not just limited to doctors or Anti-Corruption or Accountability departments but its spread all across the department. One of the most notable example in Pakistan is Karachi, where gutkas and other tobacco based or related items are allowed in Karachi by police as they take bribes from the factories and sellers and are putting the lives of citizens in danger as such products are cancerous and can causes cancers of mouth and other types. Similarly sanitation and waste management departments like Karachi Waste Management Company and Karachi Municipal Corporation are sleeping and the city is experiencing piles of waste all around the city adding to the worst picture of the city. Similarly roads and streets are damaged and require

repair but everyone is sleeping,
recently Karachi has seen a lot
of rise in snatching and looting
events by thieves and at
some instances people were also
shot during snatching. This is
a big question mark on the
performance of law enforcement agencies
that the city is bleeding under
their nose. In Quran it is
said by Almighty Allah

**"A person who kills one human
being is equal to he killed the
whole humanity."**

This is the situation of Pakistan
but this worst disease of corruption
is not just limited to Pakistan but
is worst disease of the ~~world~~.

and India respectively.~~

Corruption in India is also deeprooted
they have different scams

exposed in its history the notable ones "**Harshad Mehta Scam 1992**", "**Telgi Scam 2003**". There are also reports which exposed the worst disease. **Hindenberg Report on Adani Group** reports its inflated price and market value and after the bubble was blown by the report Adani group's market value crashed. The report say Adani group has done excessive **Irrelevant** borrowings from Banks to acquire its new ventures and this borrowing has a large portion coming from Public Government banks. This indicates that the worst disease had played its part here as well.

Telgi Scam was a stamp paper scam where the govt. treasury was being looted as the stamp papers were printed by them privately and sold around India and government treasury was getting nothing in return. This was a huge loss to the government treasury and exposed

the involvement of several government officers and departments even politicians were involved where everyone was getting its due share or agreed for ignoring it and letting it run without paying any heed.

Iran is also Pakistan's neighbour and its funding to different groups around the world like Hezbollah, Houtis and other small and large factions across the globe, so that they operate as Iran's proxies and work for their agenda at global level. Iran and Iran's Anglo-Iranian Oil Company was the bone of contention due to Iran's oil reserves and the worst disease was used by western powers to topple several govt's in Iran so that they continue to get the major share of Iran's oil i.e. 84% and 16% was given to Iran. This caused a resentment among the people overtime and resulted in several blood baths by USA and Britain supported governments against their opposition

as well as general public on the roads. Reza Pahlavi was the last ruler of Iran who was inclined towards west after that Iranian revolution came and everything went out of western hands and Iran became their worst enemy who was once a close ally. CIA was used multiple times by bribing oppositions and different parties helping them acquire power and led them to work for them.

Arranging mass protests against the Pro Iranian people centric government of Muhammad Mussadig which resulted his government's toppling.


Corruption has always been used as a tool to implement agendas.

In Afghanistan during American invasion the pro American Afghan govt. had done a lot of corruption in the country and had amassed a lot of wealth through corruption so when USA and NATO were leaving Afghanistan the government

also fled with all the corruption earned wealth to abroad.

Once our part Bangladesh is also rooted in corruption, the worst disease in the world today. Bangladesh who got separated from Pakistan in 1971 had recently mass protests by students against the corrupt practices of the government of Sheikh Hasina Wajid, daughter of Sheikh Mujib-ur-Rehman the founder of Bangladesh. Students demanded abrogation of employment quota for the families of freedom fighters as it was 30% which accounts a huge percentage. By accounting for all the quotas it comes to around 56% and the merit quota stands at only 45%.

As Bangladesh also has a large young population which is unemployed and seeking employment.

These malpractice lead to Bangladeshi youth to overthrow the govt of Sheikh Hasina Wajid who was 3rd time Prime Minister of Bangladesh.

Middle East and Africa also seen this worst disease its role. Where using it due to people being morally corrupt, it's easy to lure them to money. This has resulted several stable government of Libya, Syria, Yemen, Sudan being thrown by supporting their opposition and funding

them so they become their allies and
