## Introduction:

## Colonial Perspective :

### Positive Impact of Colonization on Gender

#### → End of practice of Sati

Before the colonial masters, Hindus practiced Sati in which widow was treated adversely once her husband die. The colonial masters Britishers ended this practice of Sati within India.

#### → Female Infanticide:

Another common practice followed was the female infanticide. Under this practice female were killed which means if a baby girl was born, she was killed. However, the colonial masters ended this by having contributed positively.

#### → Allowed to Remarry:

Women were not allowed to marry again if their husbands died. British during the period of colonization also ended this practice.

#### → Age of Consent:

The age of consent of woman was increased to 18 years. This was another positive development done by the colonial masters.

#### → Right of Inheritance:

Certain female were not given with right of inheritance. This practice was also ended by the colonial masters.

Another impact of capitalism is the unequal work force distribution. If we consider the example of Pakistan, woman only contribute to 23% of labor force participation.


→ Haves and Havesnot:

## 1<sup>st</sup> Wave of Feminism:

The first wave of feminism called out for the political and economic rights of woman through integrating them.

Mary Woolstonecraft in her book *Vindication of Rights of Woman*.

explained that how woman fought for their rights.

### Political Rights

④ It includes the issue of woman suffrage due to this the voting rights of woman emerged.

⑤ The first country to give the woman voting right was Newzealand.

③ Seneca Falls Convention by the Elizabeth was one of the key event.

The first wave of feminists used the approaches of conventions and dialogues to get the right of woman.

"Give her right and she will emulate man"

These feminists' main demand was to have equality with men, this was done through the approach of integration.

Liberal feminists come under this category.

## 2<sup>nd</sup> Wave of Feminist:

The second wave of feminist called out for providing the rights of woman but through an approach of autonomy.

This wave of feminism is denoted by a revolution where outbursts of emotions occurred that were not channelized. This lead to sexual revolution brought up by Shulamith

and Andrey. They are also referred as **separatist feminists**.

At this time the higher education institutes for the gender studies were built offering degrees in Masters and PhD programs.

### **3<sup>rd</sup> Wave of Feminism:**

Third wave of feminism emerged after 1990s. It not only talks about woman but all the genders. It advocates for homosexuality.

The **post modern feminists** come under this category. They believe there is no binarism when comes to gender but a phenomenon of **LGBTQ+** where gender is seen within psychological, sexual and biological orientation.

It not only advocates for the right of woman but men too. Many controversial issues about the gender emerged from there.

## Type of Feminism to Elevate Socio-economic Condition of Woman in Pakistan

**Liberal Feminism** offers the best solution for the issues faced by woman in Pakistan. As the aim of liberal feminist in the west was to get the women equal opportunity as men have either politically or economically. The way to solve the issues of woman in Pakistan is to engage with men about talking the grievances woman have through **integration**. If woman will have seats in Parliament or political representation in any form it is naturally apprehensive of her to make the policies that favor woman and help them in getting economic independence. This can be done through allocation of specific seats for woman, providing woman with opportunities to join the universities.

The practices of discrimination against women both socially and politically can be eliminated through this way. The large labor-force work rate gap can also be lessened through this way.
