Political intervention leads to biased judicial decisions. When judiciary is under influence of the politician, it will work and decided for their support. For instance, in India, during revocation of Article 370 in Kashmir, the right to property and permanent residence, the judiciary of ~~of~~ India decided in the favor of political ^{extremist} party BJP, leading actor Prime Minister Narendra Modi, ignoring the innocent Kashmiris. Political intervention violates rule of law. It ignores the laws passed by parliament and senate. It undermines the judicial independence while breaking rules and violating constitution of a nation. Moreover, they will humiliate the integrity and sovereignty of a state. The judiciary is dependent so, it will decide in their favor.

For instance, recently the ~~incident~~ Prime Minister occurred in North Korea where a son of politician vilified a police officer viraled on social media. The court did not take action against him but leave him with honour. Therefore, this example highlights how political interference can violate rule of law due to its influence on judicial independence.

Political intervention weakens judicial autonomy. When a country having dependent and under

influenced of politics of judiciary, the judiciary will lack its autonomy. It will not ensure justice to public. Moreover, it would be an organ working for few elite class people having background in politics. For example, in Pakistan, the judiciary lacks autonomy and work under the influence of politicians. Whenever, judiciary gives a verdict, politicians violates it and criticize its decisions.

Therefore, the example highlights how political interference can lack the autonomy of judiciary.

Judicial independence disappears against an unjust structure. The constitution clearly defines when any bill is brought in parliament or senate or when it is resolved, the judiciary have authority to cancel it if it is against the public interest. Moreover, when judiciary works under political interference, it will be a disable organ and can not promote justice

and equality. For instance, during the fall of Hasina, the daughter of Mujib-ur-Rehman, founder of Bangladesh, presented a quota for freedom fighters' children, the judiciary remained silent. This example shows how political interference can worsen judicial independence.

Having understood the ~~also~~ impacts of political interference, it is necessary to know its consequence which are essential. There are from lack of trust in public to corruption, all have their significant side.

Due to political interference, the lack of trust appears in public. When judiciary ignores public interest in favour of politicians, the people become compelled to work against their structure.
