Federal Investigation Agency (FIA) reported that 430 cases of psychologically ill people have been registered.

910 cases of child assault and 534 cases of domestic physical violence of women have been registered with 8430 other crime cases. Such figure highlights the tendency of criminal behavior in Pakistan. Therefore, government should take possible initiatives to counter rising figure with employing national awareness campaign for family protection and tolerance in the country.
