### (1) High emphasis on System of Family:

Family is the building block of any society. Therefore, Islam had put special emphasis on the family system. Within family from blood relatives to others all are emphasized as important.

### Parents:

According to Quran and Sunnah a person is most entitled to be in good conduct with their parents.

A man came to Prophet (PBUH) and asked who is to be entitled to be treated best by me. Prophet PBUH replied your mother. He asked who else after her. Prophet (PBUH) replied your mother. He again asked and Prophet (PBUH) replied your mother.

He asked again and then Prophet (PBUH) replied your father.

In Islam it is highly and repeatedly asked to have good conduct towards parents.

## **Children:**

It is emphasized to take care of children and to feed them. Furthermore, it is regarded to kill them

"Don't kill them because of fear of

poverty. It is Allah that provides for them."

(Quran)

## **Paternal and Maternal Relatives**

It is highly emphasized in Islam to have good relations with relatives.

Especially, uncle and aunt. Prophet (PBUH) said to Hazrat Ali

"Paternal uncle is like father"

"Maternal aunt is like mother" (Al-thabas)

Even after demise of parents it is advised to have good relations with relatives.

Islam provides with two ways to earn money. The first one is providing some with goods and secondly providing with services.

### → Prohibition of Riba:

Islam forbids a belief to earn any money due to interest and therefore strictly prohibits this practice

### → Making No Money Out of Money:

It is not allowed in Islam to make money out of the money. One can earn a profit on money through investments only.

### → System of Zakat

Those who have the specific amount (75 ounces of gold and 52 ounces of silver) are entitled to give the obligation

"Whoever of you can marry should marry" (Hadith)

Thus, Islam encourages believers to get married.

## Status of Minority:

Fatima (R.A) were to steal I  
would cut her hands off?"'

This shows that how perfectly  
in Islam Rule of law is applicable  
on all under period of various caliphs  
for this cause systems were made  
to uphold rule of law and proper  
judicial system was present.

## Accountability:

Another distinctive feature of Islamic  
judicial system is upholding and  
ensuring accountability.

"Each of you is shepherd and each  
of you is responsible for his flock."

(Al-Hadass)

This was one of the most practiced aspect during time of Caliph even the system of **Hisabah** was made for the purpose. Umer (R.A) even made the governor of province that he appointed to be accountable of his acts as people asked about it.

"If I am wrong help me" ~ Hazrat  
Abubakr (R.A)  
1<sup>st</sup> Caliph

## Meritocracy:

Islam strongly advocates for the system of meritocracy which refers to the system of right job for the right people. This can be illustrated through the concept that Prophet (P.B.U.H) appointed ~~Umar~~ Khalid Bin Walid as leader of an important military expedition despite seniority.
